- 7. SUBDIVISION APPLICATION:** Council to consider the submission of a plat for the minuteman Subdivision.
- 8. SUBDIVISION RESOLUTION:** Council to consider a Resolution adopting the Minuteman Subdivision.
- 9. SUBDIVISION AGREEMENT:** Council to review for approval the Subdivision agreement for Minutemen Subdivision.
