A Special Budget Workshop Meeting of the Lexington City Council was held Tuesday, August 27, 1996, at the Municipal Building, 406 East 7th Street, Lexington, Nebraska, at 6:00 P.M. Members of the City Council present were: Mayor Robert Hawks, John Wightman, Dorothy Anderson, Jerry Long and John Fagot. City Official present was: Interim City Manager Vance Bricker, and City Clerk Leon E. Malzahn. Department Heads present were: Glenn Hawks, Pete Bishop, Ann Luther, Jess Bliven, Ruth Seward, Tom Nelson and Kerry Rader.

**NOTICE:** Notice of the meeting was given in advance, thereof by publication in the Lexington Clipper-Herald, the designated method for giving notice, as shown by the Affidavit of Publication attached to these Minutes. Notice of this meeting was simultaneously given to the Mayor and all members of the Council, and a copy of their Acknowledgment of Receipt of Notice and the agenda is attached to these Minutes. Availability of the Agenda was communicated in advance notice and in the notice to the Mayor and Council of this meeting. The proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. All items presented and discussed on the agenda were available for public inspection.

**CALL TO ORDER:** The meeting was called to order by Mayor Hawks.

**BUDGET REVIEW:** The Lexington City Council reviewed the budgets which were reviewed that morning and also raised additional questions on the bond payments concerning future bond payments and the limit on bond payments. Additional questions referred to a change in the Fire Department agreement for the purchase of a building only which would change the formula from the City paying 2/3 of the building cost to the City paying 1/3 of the cost of the building. Also questioned were the number of employees at the Grand Generation Center. Ms. Ann Luther stated that they would no longer be purchasing their meals at Overton and needed additional employees to prepare these meals for distribution.

**ADJOURNMENT:**

There being no further business to come before the Council, Mayor Hawks declared the meeting adjourned.
