A Special Budget Workshop Meeting of the Lexington City Council was held Friday, August 30, 1996, at the Municipal Building, 406 East 7th Street, Lexington, Nebraska, at 7:00 A.M. Members of the City Council present were: Mayor Robert Hawks, John Wightman, Dorothy Anderson, and John Fagot. Councilperson Jerry Long was absent. City Official present was: Interim City Manager Vance Bricker, City Clerk Leon E. Malzahn. Department Heads present were: Glenn Hawks, Charles Clark, Pete Bishop, Ann Luther, Jess Bliven, Ruth Seward, Tom Nelson and Kerry Rader.

NOTICE: Notice of the meeting was given in advance, thereof by publication in the Lexington Clipper-Herald, the designated method for giving notice, as shown by the Affidavit of Publication attached to these Minutes. Notice of this meeting was simultaneously given to the Mayor and all members of the Council, and a copy of their Acknowledgment of Receipt of Notice and the agenda is attached to these Minutes. Availability of the Agenda was communicated in advance notice and in the notice to the Mayor and Council of this meeting. The proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. All items presented and discussed on the agenda were available for public inspection.

CALL TO ORDER: The meeting was called to order by Mayor Hawks.

BUDGET REVIEW: The Lexington City Council reviewed the budgets as presented for all departments and specifically the budget for bond payment. After an in-depth explanation of the amount of bonds outstanding and the payments required over a period of years for the retirement of these bonds, Interim City Manager Bricker stated that a budget hearing would be set for September 10, 1996 at the regular council meeting to set the budget for the City of Lexington ensuing year. Additional items which were discussed were the need for a fire department building and information on the computer system.

There being no further business to come before the Council, Mayor Hawks declared the meeting adjourned.
