A Organizational Meeting of the Lexington City Council was held Tuesday, December 1, 1998 at the Lexington Municipal Building, 406 East 7<sup>th</sup> Street, Lexington, Nebraska at 7:00 a.m. Members of the Council present were John Wightman, Rick Klamm, Neal Kohl. City Officials present were City Clerk Leon Malzahn, City Manager Vance Bricker, Assistant City Manager Joe Peplitsch. The Press was represented by KRVN and the Clipper-Herald.

**NOTICE:**

Notice of the meeting was given in advance, thereof by publication in the Lexington Clipper-Herald the designated method for giving notice, as shown by the Affidavit of Publication attached to these Minutes. Notice of this meeting was simultaneously given to the Mayor and all members of the Council, and a copy of their Acknowledgment of Receipt of Notice and the Agenda is attached to these Minutes. Availability of the Agenda was communicated in advance notice and in the notice to the Mayor and Council of this Meeting. The proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. All items presented and discussed on the Agenda were available for public inspection.

**CALL TO ORDER:**

The meeting was called to order by the City Clerk who administered the oath of office to the newly elected Council Persons John Fagot and Ted Cook. Upon the completion of the administration of the oath, the newly elected Council People were seated and the City Clerk conducted elections for a temporary Chair-person. Moved by Fagot, seconded by Kohl, to nominate John Wightman as temporary Chair-person. Hearing no further nominations, moved by Fagot, seconded by Kohl that nominations cease and that ballots be cast for John Wightman as temporary Chair-person. Roll call. Voting "aye" were Cook, Klamm, Kohl, Fagot, Wightman. Motion carried. The temporary Chairman then called the meeting to order stating that he would accept nominations for President of the Council. Moved by Kohl, seconded by Klamm, to nominate John Fagot as president of the Council, and that nominations cease and a unanimous ballot be cast for John Fagot as President of the Council. Roll call. Voting "aye" were Wightman, Cook, Klamm, Kohl, Fagot.

The temporary Chairman then said he would accept nominations for Vice President for the Council. Moved by Fagot, seconded by Wightman that Neal Kohl be nominated as Vice President of the Council, that nominations cease, and that a unanimous ballot be cast for Neal Kohl as Vice President of the Council. Roll call. Voting "aye" were Klamm, Cook, Wightman, Fagot, Kohl. Motion carried.

At this time, John Wightman, as temporary Chairman adjourned the meeting, and the meeting was then called to order by John Fagot, President of the Council. A discussion was held. With no further business, Mayor Fagot declared the meeting adjourned.
