A Special Meeting of the Lexington City Council was held Thursday, July 18, 2002, at the Lexington Municipal Building, located at 406 E. 7<sup>th</sup> Street, Lexington, Nebraska at 7:30 p.m. Members of the Council present were Mayor John Fagot, Ted Cook, Rick Klamm, Steve Tomasek. Councilman John Salem arrived at 8:40 p.m. City Officials present were City Manager Joe Pepplichtsch, City Attorney Willard Weinhold, Deputy City Clerk Shirley Lewis. Also present was Kevin Atkinson representing Phelps Golf Course Design. Approximately 50 citizens were also in attendance.

Mr. Atkinson reviewed his company, courses his company has designed, and various initial concepts for a proposed golf course for Lexington. Following Mr. Atkinson's presentation, there was a question and answer period. No Council action was taken.
