The best solution is to not have it enter the sanitary sewer. If it did, it would be prudent to request sampling. If you could, I would make a small summary to include in your records and/or annual report.

I do think that the facility needs to contact the Department. I think with their SIC code (2048) they need to submit a Notice of Intent for stormwater to see if they need to have a permit or qualify for non-exposure. Midwest PMS has a spill of non-pollutant material along Ivan Street. The management was contacted to immediately abate the potential of any material entering the storm sewer.

Shane Area, a local contractor, utilized a vacuum truck to clean a large portion of the spilled material. Midwest PMS, applied a drying agent and equipment to clean the remaining material from the street.

I contacted the NDEQ to report the spill and give them our input and steps to remediate the spill.
