SUBSTATION TRANFORMER	Pepplitsch requested Council approval on the acquisition of an additional
	transformer for the East Walnut Substation. He explained that this substation serves several of the industries in the area and an additional transformer would assist with increasing loads, and contingency operations per the distribution plan. As the delivery date is for 12 months, authorization is needed at this time to complete the project. Following discussion, moved by Tomasek, seconded by Miller, to authorize the transformer acquisition as presented. Roll call. Voting "aye" were Salem, Bennett, Miller, Tomasek, Fagot. Motion carried.
34.5 KV TRANSMISSION LINE:	Pepplitsch requested Council approval to construct a new 34.5 KV Electric Transmission Line from the East Lexington Substation. This would be a second circuit from the East Lexington Substation to serve the north part of Lexington and to provide contingency capacity. Following discussion, moved by Tomasek, seconded by Bennett, to authorize the transmission line project as presented. Roll call. Voting "aye" were Salem, Miller, Bennett, Tomasek, Fagot. Motion carried.

PLANNING SESSION:	Pepplitsch requested Council consideration of setting a date for a planning session to discuss several current and future projects. Following discussion moved by Tomasek, seconded by Bennett, to set a council planning session for Saturday, June 28, 2008, at 8 a.m. Roll call. Voting "aye" were Salem, Miller, Bennett, Tomasek, Fagot. Motion carried.
ROUNDTABLE:	Pepplitsch requested topics for the planning session scheduled for June 2 2008. He also reported that ABLE will be requesting an extension of the CDBG housing loan to continue the high school housing construction projet for another year. He advised that the NCMA conference is being held June 11-13 in Lexington. He gave an update of the recent storm damage and the activities of FEMA. He also reported that he recently met with the Optimist to discuss long-term plans for the Optimist Rec Complex.
	Tomasek requested an update on the city's plans to control mosquitoes f the summer, which Pepplitsch provided.
