A Planning Session of the Lexington City Council was held Saturday, December 5, 2009, at the Lexington Municipal Building, located at 406 East 7th Street, Lexington, Nebraska at 8:00 a.m. Members of the Council present were John Fagot, Joni Bennett, and Linda Miller. Council member Steve Tomasek was absent. City Officials present were City Manager Joe Peplitsch, Assistant City Manager Dennis Burnside, City Attorney Will Weinhold and Deputy City Clerk Pamela Berke.

Notice of this meeting was simultaneously given to the Mayor and all members of the Council, and a copy of their Acknowledgment of Receipt of Notice and the Agenda is attached to these Minutes. Availability of the Agenda was communicated in advance notice and in the notice to the Mayor and Council of this Meeting. - NEW NEIGHBORHOOD:** Peplitsch gave an update on the New Neighborhoods housing project.
- PERSONNEL MANUAL:** Staff informed Council on amendments that will be made to the city's personnel policy.
- FUTURE PROJECT UPDATE:** Due to time constraints, it was determined that current and future project updates would be done at a later time.
- LVFD EQUIPMENT:** Council, Staff and LVFD members toured the fire hall to discuss current equipment inventory and future needs.
- ROUNDTABLE:** Fagot noted that he will be requesting Council direction on landfill issues at the next planning session.
- ADJOURNMENT:** There being no further business to come before Council, Mayor Fagot declared the meeting adjourned.
