A Regular Meeting of the Lexington City Council was held Tuesday, September 25, 2018, at the Lexington City Hall, 406 E. 7<sup>th</sup> Street, Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, and Steve Smith. Jeremy Roberts was excused. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, Community Development Director Bill Brecks, City Attorney Brian Copley, and City Clerk Pamela Baruth. The press was represented by Clipper-Herald, KRVN, and Tri-City Tribune.

**FINANCIAL REPORT:** Moved by Salem, seconded by Vivas, to accept the financial report for August 2018 as presented. Roll call. Voting "aye" were Smith, Vivas, Salem, Fagot. Motion carried.

**PUBLIC COMMENT:** Nola Reed inquired about the city's consideration of planting vegetation in the traffic islands along Liberty Drive, noting that she has pods and seeds to donate. Mayor Fagot stated the suggestion is still being considered.

**PUBLIC HEARING:** Mayor Fagot opened a public hearing to consider a conditional use permit application by Edgar Gutierrez for a salvage yard at 507 West Vine. Brecks reviewed the project, noting that a correction to the property to be considered will be made to include lots 3-7. He noted that the Planning Commission recommended approval. Mr. Gutierrez stated that he will only be salvaging vehicles for parts and plans to haul away unusable units. Salem expressed concerns about the view from the Adams Street overpass. A draft conditional use permit agreement was reviewed and two corrections noted. There being no public comments, the public hearing was closed. Following discussion, moved by Smith, seconded by Vivas, to approve the conditional use permit application and agreement as corrected. Roll call. Voting "aye" were Salem, Vivas, Smith, Fagot. Motion carried.

**APPOINTMENT:** Moved by Vivas, seconded by Salem, to appoint Barb Margritz and Chris Denker to replace Curt Bennett and Keevin Hardiman on the Lexington Planning Commission. Roll call. Voting "aye" were Smith, Salem, Vivas, Fagot. Motion carried.

**WORK SESSION:** Moved by Salem, seconded by Vivas, to schedule a council work session for Saturday, October 13, 2018, at 8:00 a.m. Roll call. Voting "aye" were Smith, Vivas, Salem, Fagot. Motion carried.

**ROUNDTABLE DISCUSSION:** There were no items for discussion.

**ADJOURNMENT:** There being no further business to come before the Council, Fagot declared the meeting adjourned.
