## 7th & Tyler

Work has begun on a new Fire Department garage. The new structure will look similar to the existing garage just south (6th & Tyler), and more than double the Department's ability to house emergency vehicles and other equipment. The project planning and costs are being shared between the City and Lexington Rural Fire District.

### **South Adams Street**

The first house in Lexington's new CED Addition is progressing nicely after the August 13 groundbreaking. Most of the first house will be built by high school students as practical experience for a construction curriculum. It is a collaborative project initiated by Dawson Area Development's ABLE program and Lexington Public Schools. Up to 21 more houses are planned for the first phase of building in this new residential neighborhood.

Items accepted include yard and garden chemicals; pesticides, herbicides, flammables; paints and thinners, auto products, used oil, antifreeze, household products and cleaning chemicals, Mercury, batteries; auto, lead acid and/or rechargeable, titanium, cadmium and nickel halide. No infectious waste and needles, radioactive waste, asbestos, oil or paint containing PCB's high school labs, appliances, construction waste and tires. Materials should be delivered to collection sites in sturdy, disposable containers labeled according to contents and no larger than 5 gallon or 50 lbs. The HHW program reserves the right to reject materials.





# Lexington snow and ice removal

**W**inter will soon be here once again. Before the first winter storm of the season, the City would like to remind citizens of the following points related to snow removal. There is also an Emergency Snow Route map on Page 5.

Removal of snow and ice from sidewalks abutting your property is required within 48 hours after such has fallen. Remember that the removal of snow and ice from sidewalks not only ensures safe passage for pedestrians (including school children), but limits liability arising from potential injuries sustained to individuals due to your neglect of the sidewalk condition.


Please remember that snow and ice removed from your property is not to be placed into the street, rather place it in nonpaved areas.

The City needs the cooperation of all citizens in its efforts of snow and ice removal from the streets. Citizens are encouraged to listen to local radio stations or read the local newspaper for announcements of possible Snow Emergency situations where substantial snowfall is experienced or anticipated.

In times of a declared Snow Emergency, parking along the street in the designated Snow Emergency Route is prohibited. Commercial Area may also be included. (See attached map for

Area description).

Citizens living along this Route are encouraged to obey the prohibition and move their vehicles from the street. (See map on Page 5 for Route description).



In addition, during a Snow Emergency, prohibition of parking in the Downtown In nonemergency times, citizens are still encouraged to move their parked vehicles off of the street in a reasonable period of time after snowfall to allow for the clearance of snow and ice by City crews. Information regarding the removal of snow in your area of the City can be obtained

The City of Lexington would like to reiterate that snow and ice removal is important for vehicular traffic as well as pedestrian traffic.

Please take the time to do your part to keep our streets and sidewalks safe.


