## Mobile Children's Museum to Visit Lexington This Summer

This summer Lexington will be one of 42 Nebraska cities to host NE 150 Celebration's "Truckin' Through Nebraska: A Mobile Children's Museum." The 26-week tour will start in April, although exact dates for each city have not yet been determined.

Lexington's time with the exhibit will be on the grounds of the Dawson County Historical Museum, 805 N. Taft Street. The next closest cities will be Holdrege and Broken Bow.

With a focus on Nebraska history, this outreach is a part of Nebraska's Sesquicentennial Celebration, marking 150 years of statehood. While exhibits in the Mobile Children's Museum are intended for children ages 5-12, audiences of all ages are welcome. Admittance is free and open to the public.

The Mobile Children's Museum is contained in a 53-foot state-of-the-art custom air-ride, double-expandable trailer that is specially designed and outfitted for traveling museum exhibits. The unit is climate controlled, has GPS tracking, Wi-Fi, its own generator

and is ADA accessible. Interior exhibits will include areas where kids will build shelters and test them in a wind chamber or earthquake simulator, design their own simulated 10-acre homestead, test their

knowledge of Nebraska, create their own movie, explore toys from the past, craft their own postcards and more.

Exhibits will also surround the exterior of the trailer, allowing for optimal play and learning space. Those exhibits will include a timed "chore" challenge obstacle course, foam block invention area, toy creation station and more.

The Mobile Children's Museum is sponsored in part by Children's Hospital and First National Bank. Much of the credit for guiding this project goes to Omaha's Children Museum.

Remember, you can save water



### Save Water

Did you know that each of us uses **77 gallons of water a day**?

When we over-water our lawns, the excess water carries pollution into storm drains and ditches that lead directly to our lakes and rivers.

#### So what can you do? Simple:

- Treat water as a valued resource. Water when necessary, instead of on a fixed schedule.
- Adjust your sprinklers to water only your lawn and plants – not your driveway, sidewalk or street.
- Use mulch around trees and plants to help retain water, reduce weeds, and minimize the need for pesticides.
- Use rainwater to water your plants by directing downspouts toward your plants, or by collecting water with rain barrels.
- Make your lawn cheaper and easier to maintain by mowing high – three inches is the rule. Longer grass has deeper roots and requires less water.

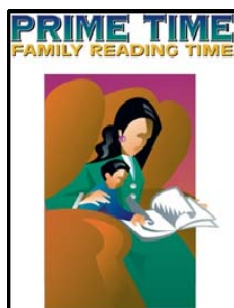

The Lexington Public Library is taking registrations for **Prime Time Family Reading Time** (Spanish/English)! If

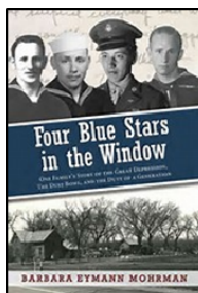

## Historic City Happenings Headlines



**2009**

The Lexington Police Department got a new radar trailer. Grant money paid for all the \$10,000 cost of the solar-powered unit.



**2010**

The Concessions/Restroom building near the Optimist Recreation Complex soccer stadium was completed. The building is now attached to the new Lexington Fieldhouse.



**2011**

Both Lexington water towers were repainted, incorporating the City's logo and the legend, "EST. 1874." Fun fact: the official name of the color is "Wicker."

**2012**

Ground was broken for a new Orthman Manufacturing plant in the City's new Southeast Business District. That plant went into full operation last year.



**2013**

The Nebraska Department of Economic Development (DED) awarded the City of Lexington \$225,000 in Community Development Block Grant (CDBG) funding to renovate the Majestic Theater.



## EnergyWise Tip: **EnergyGuide Labels**



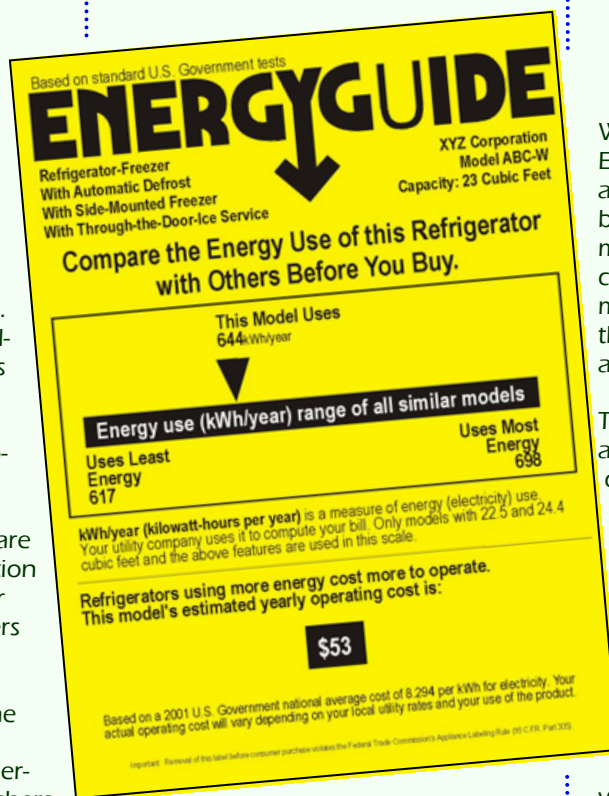
Have you been shopping for a refrigerator or washer lately? If so, you probably noticed many of the appliances in the store have a bright yellow and black label on them. While you may know this “EnergyGuide Label” provides an idea of what it will cost to operate the appliance, most people are not aware of how to gain the most value from the information it contains.

First of all, it is worth noting that appliance energy labels have been around for quite a while. The Federal Trade Commission (FTC) issued the Energy Labeling Rule in 1979 pursuant to the Energy Policy and Conservation Act of 1975. The rule requires energy labeling for major home appliances and other consumer products to help consumers compare competing models. It also prohibits retailers from removing the labels or rendering them illegible. In addition, retailers are directed to post label information on their websites and in paper catalogs from which consumers order products.

When it was first published, the rule applied to eight product categories: refrigerators, refrigerator-freezers, freezers, dishwashers, water heaters, clothes washers, room air conditioners and furnaces. Over time the FTC expanded the rule to include central air conditioners, heat pumps, plumbing products, lighting products, ceiling fans and televisions. Clothes dryers, dehumidifiers, humidifiers, ovens and ranges are still exempt from labeling.

EnergyGuide labels contain three key product disclosures: Estimated annual energy cost; a product’s energy consumption or energy efficiency rating as determined from U.S. Department of Energy test procedures; and a comparability range displaying the highest and lowest energy costs or efficiency ratings for all similar models.

3. A cost range to compare the energy use of different models with similar features.
4. An estimate of how much electricity the appliance uses in a year based on typical use.
5. If you see the ENERGY STAR® logo on the label too, it means the appliance met certain quality, energy efficiency, environmental and warranty criteria to be considered better than average.



What if you cannot find the EnergyGuide label on the appliance, Look inside or on the back of the appliance; the label might be there. You can also check the retailer’s or manufacturer’s websites to see the EnergyGuide for a particular appliance.

Though shopping for the right appliance can be difficult when considering all the features, product reviews and prices, the EnergyGuide label can at least reduce some of the questions you might have about energy usage. While there are four particular formats for EnergyGuide labels, all four present the following:

1. The manufacturer, model and size of the appliance it is attached to.
2. Cost to run the appliance for a year, based on its electric use in an “average” household and the national average cost of energy.
