Magaalada Lexington iyadoo la kaashaneysa Maamulka Fidinta Federalka (FHWA) waxay qabanaysaa dhageysi dadweyne oo la xiriira soojeedinta dhismaha horumarinta iyo hagaajinta wadooyinka ee agagaarka Xarunta Wadada 435, Isgoyska Wadada Pacific Pacific (UPRR), iyo Wadada US 30. (US-30) dhanka bari ee Lexington ee Dawson County. Dhageysiga wuxuu ka dhici doonaa Xafiiska Golaha Magaalada - Lexington Dowlada Hoose, 406 E 7th Street ee Lexington Khamiista, 12ka Sebtember, 2019, laga bilaabo 4:00 illaa 6:00 PM.

Dhageysiga dadweynaha waxaa loo qabanayaa si loogu soo bandhigo Qabyo-qoraalka Qiimaynta Deegaanka (DEA) dadweynaha si loo ogaado faallooyinkooda iyo su'aalhooda ku saabsan DEA. DEA waxay soo bandhigaysaa waxyaabaha kale ee la qiimeeyay, saamaynta la aqoonsaday, iyo talaabooyinka yareynta yareynta mashruuca; kuwaas oo saldhig u ahaa falanqaynta bulshada, dhaqaalaha, iyo bay'ada ee loo sameeyay mashruucan.

Dhammaan dadka xiiseynaya waxaa lagu casuumay inay ka soo qeybgalaan dhageysiga dadweynaha oo ay soo bandhigaan faallooyinka iyo su'aalaha la xiriira. Qaabka waxaa ku jira guri furan laga soo bilaabo 4:00 PM illaa 5:00 PM, soo bandhigid rasmi ah ta galabnimo 5:00 PM illaa 5:20 PM, iyo madal dadweyne laga bilaabo 5:20 PM illaa 6:00 PM. Xubnaha dadweynaha ee raba inay ka bixiyaan faallooyinka kulanka dadweynaha waxaa la weydiisan doonaa inay iska qoraan si ay u hadlaan; Waqtiga wuxuu ku koobnaan doonaa saddex daqiiqo si loogu oggolaado ka-qaybgalka ugu badan. Haddii loo baahdo, kulanka dadweynaha waxaa la dheereyn doonaa wixii ka dambeeya 6:00 PM si loo qaabilo dhammaan kuwa ku hadla. Waqtiga haray ayaa noqon doona qaab guri furan oo dadweynuhu ay soo booqan karaan oo ay ku wada hadli karaan mid-mid ah wakiilada mashruuca.

Faallooyinka ayaa la soo ururin doonaa illaa Jimcaha, Sebtember 27, 2019, waana in boostada ama emaylka loo diraa taariikhdan si ay uga mid noqdaan diiwaanka rasmiga ah. Dhammaan faallooyinka iyo jawaabaha waa la qaddarin doonaa waxaana lagu dari doonaa Final-ka EA, dhammaan faallooyinkana waxay jawaab rasmi ah ka heli doonaan Magaalada.

Natiijada baaritaanka iyo macluumaadka ka soo uruuriyay guriga furan ee Noofembar 2013, laba ka mid ah afarta beddelaad ayaa laga ciribtiray qiimeyn dheeraad ah. Waxyaabaha aan la dhisiin ee ah 'Wax Dhis Nololeed ah' (Waxba ha qaban) iyo Kala-doorbidista Beddelka ah si loo dhiso khariidad cusub oo woqooyi-koonfur ka dhacda UPRR iyo US-30 ayaa loo sii waday qiimaynta faahfaahsan ee DEA. Iyada oo qayb ka ah horumarinta mashruucan, Magaalada Lexington waxay dhisi doontaa laba waddo oo maxalli ah oo cusub si ay u sii waddo marin u helidda aagga, u dejiso Wadda Waddada 755 ee Waddada 435 si ay u bixiso is-goys fiican oo loo maro US-30, oo ay abuurto dariiqo iyo garbaha ee US-30 ee isgoyska loo raray ee Wadada County 755.

Waxaa loo aqoonsaday in laga dhiso Lexington Buundo Xaga Bari, mashruucan lasoo jeediyay wuxuu dhisi doonaa waddo cusub oo woqooyi-

koonfur ka xigta dhinaca Wadada 435 ee loo maro UPRR iyo US-30 wuxuuna xirayaa isgoysyada hadda jira ee marinka UPRR ee Wadada County 435 iyo Wadada County 436.

Ujeedada mashruucan ayaa ah in la wanaajiyo qulqulka taraafikada agagaarka isgoyska County Wadada 435, US-30 iyo UPRR. Baahida loo qabo mashruucan ayaa ah in la yareeyo shilalka ka dhaca Wadada County 435 ee u dhaw US-30 iyo isgoysyada UPRR, in la yareeyo daahitaanka gawaarida ka gudba wadada isku xirta UPRR ee ku taal wadada Wadada 435 iyo in la bixiyo helitaan la jaan qaada qorshooyinka ay ansixisay Magaalada Lexington.

Xaquuqul-istiraatiijiyadani waxay ka koobnaan kartaa xuquuq cusub oo ah dar-dar (ROW), fududeyn joogto ah (PE), iyo / ama fududeyn ku meel-gaar ah (TE). Helitaanka hada ee ganacsiyada badan ayaa isbadali doonta. Haddii hantidaada mashruucan uu saameeyo mashruucan, wakiil ayaa kula soo xiriiri doona mar alla markii naqshadeynta naqshadeynta la aasaaso. Helitaanka guryaha ku xeeran waa la ilaalin doonaa inta dhismaha lagu jiro. Gaaritaanku waa xaddidi karaa baahiyaha wejyada darteed.

Mashruuca la soo jeediyay looma dhisi doono taraafikada waxayna u baahan doontaa in la dayactiro US-30 iyo taraafikada maxalliga ah. Jid loogu tala galay taraafikada US-30 ayaa la bixin doonaa iyadoo la adeegsanayo USwayway 283 (US-283), Interstate 80 (I-80), iyo Nebraska Link 24B (L-24B). Waddo go'an oo loogu talagalay taraafikada gudaha ayaa la bixin doonaa iyadoo la adeegsanayo County Street 756 iyo Taft Street waqooyiga ee US-303 iyo US-283 iyo East Walnut Street ama County Road 754 koonfurta Mareykanka-30.

Dhismaha 2 sano ee la filayey inuu bilawdo bilowga asalka 2021 oo la dhammeeyo dhamaadka 2023.

Saamaynta yar ee dhul-beereedka, durdurrada, dhul-beereedka iyo dooxooyinka ayaa la filayaa mashruucan awgiis. Saamaynta kuma yeelan jardiinooyinka, dhulalka dadweynaha ama guryaha madaddaalada lama filayo.
