UJEDDO IYO BAAHI


Ujeedada mashruucan ayaa ah in la wanaajiyo qulqulka taraafikada agagaarka isgoyska County Wadada 435, US-30 iyo UPRR. Baahida loo qabo mashruucan ayaa ah in la yareeyo shilalka ka dhaca Wadada County 435 ee u dhaw US-30 iyo isgoysyada UPRR, in la yareeyo daahitaanka gawaarida ka gudba wadada isku xirta UPRR ee ku taal wadada Wadada 435 iyo in la bixiyo helitaan la jaan qaada qorshooyinka ay ansixisay Magaalada Lexington.

BAAXADDA SHAQADA

Mashruuca la soo jeediyay wuxuu dhisi doonaa waddo cusub oo waqooyi-koonfur ah oo loo maro Wadada County 435 oo ka sarreysa UPRR iyo US-30 waxayna xiraysaa isgoysyada hadda jira ee marinka UPRR ee Wadada Wadnaha 435 iyo Wadada County 436. Iyada oo qayb ka ah horumarinta mashruucan, Magaalada Lexington waxay dhisi doontaa laba waddo oo maxalli ah oo cusub si ay u joogteeyaan marin u helidda aagga, ka dib markii loo hagaajiyo Waddada County 755 ee laga soo bilaabo Degmooyinka County 435 si loo bixiyo isgoys fiican oo loo maro US-30, oo loo aburo dariiqo iyo garbaha ee US-30 ee isgoyska loo raray ee Wadada County 755.

TAARIKHDA MASHRUUCA

Magaalada Lexington waxay qabatay kulan dadweyne oo loogu talo galay mashruuca la soo jeediyay November 7, 2013, Dhismaha Dawlada Hoose ee Lexington si ay u soo bandhigaan ujeedada iyo baahiyaha iyo waxyaabaha kale ee la soo jeediyey ee lagu soo saaray mashruuca la soo jeediyey. Natiijada baaritaanka iyo macluumaadka ka soo uruuriyay guriga furan ee Noofembar 2013, laba ka mid ah afarta beddelaad ayaa laga ciribtiray qiimeyn dheeraad ah. Waxyaabaha aan la dhisin ee ah 'Wax Dhis Nololeed ah' (Waxba ha qaban) iyo Kala-doorbidista Beddelka ah si loo dhiso khariidad cusub oo woqooyi-koonfur ka dhacda UPRR iyo US-30 ayaa loo sii waday qiimaynta faahfaahsan ee DEA. DEA waxay soo bandhigaysaa waxyaabaha kale ee la qiimeeyay, saamaynta la aqoonsaday, iyo talaabooyinka yareynta yareynta mashruuca; kuwaas oo saldhig u ahaa falanqaynta bulshada, dhaqaalaha, iyo bay'ada ee loo sameeyay mashruucan.



QORSHAHA TARAAFIKADA

Mashruuca la soo jeediyay looma dhisi doono taraafikada waxayna u baahan doontaa in la dayactiro US-30 iyo taraafikada maxalliga ah. Jid loogu tala galay taraafikada US-30 ayaa la bixin doonaa iyadoo la adeegsanayo USwayway 283 (US-283), Interstate 80 (I-80), iyo Nebraska Link 24B (L-24B). Waddo go'an oo loogu talagay taraafikada gudaha ayaa la bixin doonaa iyadoo la adeegsanayo County Street 756 iyo Taft Street waqooyiga ee US-303 iyo US-283 iyo East Walnut Street ama County Road 754 koonfurta Mareykanka-30.

Haddii aad leedahay hanti ay saameyn ku leedahay mashruucan, wakiil ayaa kula soo xiriiri doona mar alla markii naqshadeynta naqshadeynta la aasaaso.

RIGHT-OF-WAY

Xaquuqul-istiraatiijiyadani waxay ka koobnaan kartaa xuquuq cusub oo ah dar-dar (ROW), fududeyn joogto ah (PE), iyo / ama fududeyn ku meel-gaar ah (TE). Helitaanka hada ee ganacsiyada badan ayaa isbadali doonta. Haddii
