

ORDINANCE RECORD

No. 728 *** K-B PRINTING Co. *** OMAHA

CITY HALL LEXINGTON, NEBRASKA

The Mayor and Council of the City of Lexington, Dawson County, Nebraska, met in regular ~~special~~ session in the City Hall at 8:00 o'clock P. M., on April 8, 1937. Mayor Kjar presided and City Clerk Olsson recorded the proceedings of this meeting.

The Mayor instructed the Clerk to call the roll. The Clerk called the roll and the following Councilmen were present: Gillan, Morganson, Hagadone, Spies, Barrett, Evans.

Absent: none.

Whereupon the Mayor announced that the introduction of ordinances was now in order, and the matter now coming before the Mayor and Council was the passage and approval of Ordinance No. 327 of the City of Lexington, Nebraska.

This ordinance was introduced by Councilman Evans and is in words and figures as follows, to wit:

ORDINANCE NO. 327

An ordinance to regulate, prohibit and to declare a nuisance the going upon private residence property in the City of Lexington, Nebraska, by solicitors, peddlers, hawkers, itinerant merchants and transient vendors of merchandise, to solicit orders or for the sale of goods, wares and merchandise, and to provide a penalty for the violation thereof, and to repeal any ordinance in conflict herewith.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. That the practice of going in and upon private residence and residence property in the City of Lexington, Nebraska, by solicitors, peddlers, hawkers, itinerant merchants and transient vendors of merchandise, not having been requested or invited to do so by the owner or owners, occupant or occupants, of said private residence, for the purpose of soliciting orders for the sale of goods, wares or merchandise, including books, periodicals and magazines, or for the purpose of disposing of, or peddling or hawking the same, or for the purpose of soliciting invitations to call at some later date to solicit orders for goods, or for the sale thereof, is hereby prohibited and declared to be a nuisance, and such nuisance shall be punishable as a misdemeanor.

Section 2. The police officers of said City of Lexington are hereby required and directed to suppress the same and to abate any such nuisance as is described in the first section of this ordinance.

Section 3. Any person or persons convicted of violating any of the provisions of this ordinance, or of perpetrating a nuisance as described and prohibited by this ordinance, shall, upon conviction thereof, be fined in any sum not less than \$10.00, nor more than \$100.00, and shall be confined to the City or County Jail until such fine and costs are fully paid.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
