The Mayor and Council of the City of Lexington, Dawson county, Nebraska, met in regular special session in the City Hall at 8:00 o'clock P. M., on March 13, 1939. Mayor Kjar presided and City Clerk Olsson recorded

the proceedings of this meeting.

The Mayor instructed the Clerk to call the roll. The Clerk called the roll and the following Councilmen were present: Gillan, Morganson, Seaman, Morgan, Evans.

Absent: Councilman Barrett.

Whereupon the Mayor announced that the introduction of ordinances was now in order, and the matter now coming before the Mayor and Council was the passage and approval of Ordinance No. 350 of the City of Lexington, Nebraska.

This ordinance was introduced by Councilman Evans words and figures as follows, to wit:

## ORDINANCE NO. 350.

APPROPRIATION BILL.

ce appropriating surplus fund

An ordinance appropriating surplus funds of the City of Lexington, Now on hand, to be used by said City, together with A.P.A. labor and material, for the construction of a garage and storage building in said City.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1.: The Mayor and Council of the City of Lexington, Nebraska, find and determine: That said City has on hand the following surplus funds: General Fund, \$1,000.00; Light Fund, \$1,000.00; Fire Equipment Fund, \$1,000.00; and Fire Maintenance Fund, \$1,000.00; that there has been filed with the City Clerk of said City, On March 6, 1939, petitions signed by a majority of the legal voters of the City of Lexington, petitioning the Mayor and Council of said City to appropriate from surplus funds now on hand the sum of \$4,000.00 to be used by said City, together with W.P.A. labor and material, for the construction of a garage and storage building, either for the use of said City or for the purpose of leasing to the local unit of the National Guard, and said construction to be on property owned by said City.

Section 2. That there is hereby appropriated out of surplus funds now on hand, in the following funds, the total sum of \$4,000.00, as follows: \$1,000.00 from the General Fund; \$1,000.00 from the Light Fund; \$1,000.00 from the Fire Equipment Fund; and \$1,000.00 from the Fire Maintenance Fund. Said funds shall be used by said City, together with W.P.A. Tabor and material, for necessary expense in connection with the construction of a garage and storage building on property owned by said City and within the corporate limits of said City.
