## CITY HALL LEXINGTON, NEBRASKA

The Mayor and Council of the City of Lexington, Dawson County, Nebraska, met in regular ~~special~~ session in the City Hall at 8:00 o'clock P.M., on April 10, 1939. Mayor Kjar presided and City Clerk Olsson recorded the proceedings of this meeting.

The Mayor instructed the Clerk to call the roll. The Clerk called the roll and the following Councilmen were present: Gillan, Morganson, Seaman, Morgan, Evans.

Absent: Councilman Barrett.

Whereupon the Mayor announced that the introduction of ordinances was now in order, and the matter now coming before the Mayor and Council was the passage and approval of Ordinance No. 353 of the City of Lexington, Nebraska.

This ordinance was introduced by Councilman Morgan and is in words and figures as follows, to wit:

### ORDINANCE NO. 353

AN ORDINANCE TO PROHIBIT THE POSSESSION, USE AND SALE OF ALL FIREWORKS IN THE CITY OF LEXINGTON, NEBRASKA, AND PROVIDING A PENALTY FOR THE VIOLATION THEREOF.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. That it shall hereafter be unlawful for any person, persons, firm or corporation to have possession of, either for sale or for any other purpose, to offer for sale or to use, within said City, any fireworks of any kind, excepting, however, from the provisions hereof, cap pistols and the caps used therein, and except upon the issuance of a permit as hereafter provided.

Section 2. Any person, persons or organization desiring to have or to hold a fireworks display within said City, shall file with the City Clerk an application in writing for a permit therefore, which application shall set forth and specifically designate the place where such fireworks display is to be held, the kind and quantity of fireworks to be used, the time thereof, and the person or persons to have supervision thereof, and the Mayor and Clerk may thereupon issue, or refuse to issue, a permit in writing for the holding of such fireworks display, excluding all fire-crackers, at the time and place and under the supervision of the person or persons as set forth in said application, and upon the issuance of any permit may require such additional supervision as shall be deemed necessary or proper, which requirement shall be stated in the permit.

Section 3. Any person, persons, firm or corporation who shall violate any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and shall, upon conviction thereof, be fined in any sum not less than \$1.00 nor more than \$25.00, and shall be committed to jail until such fine and costs are fully paid.
