CITY HALL LEXINGTON, NEBRASKA

The Mayor and Council of the City of Lexington, Dawson County, Nebraska, met in regular special session in the City Hall at 8 o'clock P M., on Second Day of July Mayor Battle presided and W. R. Egenberger City Clerk recorded the proceedings of this meeting.

The Mayor instructed the Clerk to call the roll. The Clerk called the roll and the following Councilmen were present: Morgan, Stewart, Power, Seaman, Britton, Haworth.

Absent: None

Whereupon the Mayor announced that the introduction of ordinances was now in order, and the matter now coming before the Mayor and Council was the passage and approval of Ordinance No. 362 of the City of Lexington, Nebraska.

This ordinance was introduced by Councilman Seaman and is in words and figures as follows, to wit:

Annual Appropriation Bill ORDINANCE NO. 362

An ordinance appropriating some of the money of the City of Lexington, Dawson County, Nebraska, for the purpose of paying liabilities, current expenses and for necessary improvements for the fiscal year 1940.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA.

Section 1. That there is hereby appropriated out of the money to be raised by general levy of the taxes upon all property within the City of Lexington, Nebraska, and of money now on hand and from money to be received from collection of water rent and money to be received from the County for road fund, for the purpose of paying present liabilities, current expenses, and for necessary improvements and expenses of said City for the fiscal year 1940, the following sums of money, to-wit:-
