CITY HALL LEXINGTON, NEBRASKA

The Mayor and Council of the City of Lexington, Dawson County, Nebraska, met in regular special session in the City Hall at 8:00 o'clock p. M., on October 14, 1941 acting Mayor Louis J. Stewart City Clerk Egenberger recorded the proceedings of this meeting.

The Mayor instructed the Clerk to call the roll. The Clerk called the roll and the following Councilmen were present: Ingram, Seaman, Brittan, Lincoln.

Absent: Councilman Haworth.

Whereupon the Mayor announced that the introduction of ordinances was now in order, and the matter now coming before the Mayor and Council was the passage and approval of Ordinance No. 368 of the City of Lexington, Nebraska.

This ordinance was introduced by Councilman Lincoln and is in words and figures as follows, to wit:

ORDINANCE NO. 368

Sewer District No. 25

Whereas, the City Council, of the City of Lexington, Nebraska, has on file a petition signed by more than 51% of the resident owners, of the Lots situated on Block One, of James Ervins First Subdivision, and Block Three and Two, of Stuckey and Little's Addition, to the City of Lexington, and that the City Council deem it advisable and necessary to construct a sewer lateral extending from a point approximately ten feet East of the East line of South Harrison Street, in the alley of Block One, of James Ervins First Subdivision, thence East through Block One of James Ervins First Subdivision; thence East through Block Three and Two, of Stuckey and Little's Addition to a point Sixteen feet East of the West line of South Washington Street, thence due North to the present sewer, and

Whereas, the City Engineer has filed with the City Clerk, his estimate of the total costs of said improvement, and the City Council has accepted and adopted said estimates, and declared the advisability and necessity for said improvement.

Therefore be it Resolved by the Mayor and City Council, of the City of Lexington, Nebraska.

- 1. That Sewer Lateral District No. 25, is hereby created in the City of Lexington, Nebraska.
- 2. Sewer Lateral No. 25, in the said City, shall include all of the Lots and parcels of Land, in Block One, of James Ervins First Sub-division, Block three and Two, of Stuckey and Little's Addition, all being within the corporate limits of the City of Lexington.
- 3. That the construction of said lateral is advisable and necessary and that said sewer shall be laid through the alley of said Block One, in James Ervins First Sub-division, and the alley in Block Three and Two, in Stuckey and Little's Addition, thence North along the West line of South Washington Street, to the present sewer.
- 4. Said sewer shall be constructed according to the plans and specifications of the City Engineer, using Vitrified Clay Tile, or Concrete Tile, hard burned brick for the man hole walls, with concrete base. The engineer's estimate of the costs of said improvement complete, being the sum of \$2328.66.

5. The entire costs of said Sewer Lateral, in said district with man holes and automatic Siphon complete, shall be levied and assessed against all of the property in the blocks above designated and the costs thereof shall be levied and assessed against said property as soon as the costs thereof may be ascertained as provided by law.
