

ORDINANCE NO. 538

An Ordinance to annex to the City of Lexington, Nebraska, the following described real estate, to-wit: "The Sub-division of a part of Tracts "B" and "C" and all of Tracts ~~"M"~~"M" and "L" of the Sub-division of the East one-half of Section Six (6), Township Nine (9), Range Twenty-one (21) West of the Sixth P.M. in Dawson County, Nebraska, as the same is now platted and sub-divided:"

Whereas the real estate above described, contiguous and adjacent to the City of Lexington, Nebraska, has been, by Decree of the District Court of Dawson County, Nebraska, annexed to said City of Lexington, in a certain action in the said Court being Case No. 10468, wherein City of Lexington, Dawson County, Nebraska, is plaintiff vs. Edmond C. Jarvis, et al, are defendants, as shown by the records in the Office of the Clerk of the District Court of Dawson County, Nebraska; and

Whereas, said Decree was made and entered on the 11th day of April, 1949, and no appeal from said Decree was perfected by the defendants, and time for such appeal has now elapsed, and

Whereas a certified copy of the above mentioned Decree has been filed with the Register of Deeds of Dawson County, Nebraska, and

Whereas the provisions of Section 17-411, Revised Statutes of Nebraska, 1943, provide that the Council of the city shall pass an Ordinance declaring such territory to be annexed to the said city and extending the corporate limits thereof accordingly, and shall file a certified copy of said Ordinance in the Office of the Register of Deeds, Dawson County, Nebraska:

THEREFORE, BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. That the real estate described as follows, to wit:


The Sub-division of a part of Tracts B and C and all of Tracts ~~"M"~~"M" and L of the Sub-division of the East one-half of Section Six (6), Township Nine (9), Range Twenty-one (21) West of the Sixth P.M. in Dawson County, Nebraska;

be and the same is hereby included within the boundaries and territories of the City of Lexington, Nebraska, and said lands and the persons residing thereon shall hereafter be subject to all of the rules, regulations, ordinances, taxes and all other burdens and benefits of other persons and territory included within


the City of Lexington, Nebraska, and the corporate limits of said city are hereby extended to include the real estate above described.

Section 2. This ordinance shall take effect and be in full force from and after its passage, approval and publication as required by law.
