

ORDINANCE NO. 544

ANNUAL APPROPRIATION BILL

An Ordinance appropriating money of the City of Lexington, Dawson County, Nebraska, for the purpose of paying liabilities, current expenses and for necessary improvements for the fiscal year 1949.

BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:


Section 1. That there is hereby appropriated out of money to be raised by a general levy of taxes upon all property within the City of Lexington, Nebraska, and of money now on hand and money to be received from collection of water rents, for the purpose of paying present liabilities, current expenses and for necessary improvements and expenses of said City, for the fiscal year 1949, the following sums of money, to-wit:


