ORDINANCE NUMBER 618

An Ordinance extending the corporate limits of the City of Lexington to include the real estate annexed to said City by Decrees of the District Court of Dawson County, Nebraska, and in accordance with the provisions of Section 17-411 Revised Statutes of Nebraska, 1943, and for the annexation thereof.

BE IT OFDAINED BY THE PRESIDENT OF THE COUNCIL AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. The President of the Council and Council of said City find that Decree was entered in the District Court of Dawson County, Nebraska, on April 27, 1949, in Case No. 10479, wherein City of Lexington, Dawson County, Nebraska, was plaintiff, and John W. Haworth and others were defendants, for the annexation to said City of the real estate described as follows:

A part of the Subdivision of Section Five (5) in Township Nine (9) North, Range Twenty-one (21), West of the 6th P.M. in Dawson County, Nebraska, described as follows:

All of Lot One (1) of Tract A; All of Lots One (1) to Fourteen (14) inclusive in East Lynn Addition to the City of Lexington, together with dedicated streets and alley, being a part of said Tract A as surveyed, platted and recorded; The South One Hundred Fifty (150) feet of Lot Three (3), Tract A, except that part of said Lot Three (3) designated and platted as East Lynn Addition to the City of Lexington; A strip of land in Lot Three (3) of said Tract A, Thirty (30) feet in width and Five Hundred Ten (510) feet in length, adjoining East Lynn Addition on the east side thereof and dedicated for road purposes and becoming a part of Polk Street as dedicated in the Plat of said East Lynn Addition;

Addition on the east side thereof and dedicated for road purposes and becoming a part of Polk Street as dedicated in the Plat of said East Lynn Addition;

All of Tract B;

Lot Four (4), the South Three Hundred Forty (340)
feet of Lot Five (5), and all of Lot Six (6) in Tract C;
Lots Seven (7), Eight (8), Nine (9), Ten (10), Thirteen (13), Fourteen (14), Fifteen (15), Sixteen (16), Seventeen (17), Eighteen (18), Nineteen (19) and Twenty (20) of Tract D;

A Part of Tract E. described as follows:

A Part of Tract E, described as follows: Commencing at the Northwest corner of Tract E, thence East One Hundred Fifty (150) feet, thence South One Hundred (100) feet, thence West One Hundred Fifty (150) feet, thence North One Hundred (100) feet to the place of beginning;

That pursuant to said Decree and Stipulation between the City of Lexington and Wilbur C. Zimmerer and Evelyn J. Zimmerer, defendants in said action, a strip of land Thirty (30) feet in width and Five Hundred Ten (510) feet in length, as herein described, adjoining the dedicated street on the east side of East Lynn Addition to said City, was dedicated by the said Wilbur C. Zimmerer and Evelyn J. Zimmerer for a road and for public use, the same to become a part of Polk Street.

Section 2. The President of the Council and Council of said City find that Decree was entered in the District Court of Dawson County, Nebraska, on June 25, 1949, in Case No. 10526, wherein City of Lexington, Dawson County, Nebraska, was plaintiff, and Howard C. Richards and others were defendants, for the annexation to said City of the real estate described as follows:

Page 2.

All of Tract E of the Subdivision of Section Five (5) Township Nine (9) North, Range Twenty-one (21) West of the 6th P.M. in Dawson County, Nebraska, EXCEPT a tract heretofore annexed to said City and described as follows; Commencing at the Northwest corner of said Tract E, thence East One Hundred Fifty (150) feet, thence South One Hundred (100) feet, thence West One Hundred Fifty (150) feet, thence North One Hundred (100) feet to the place of beginning;

Section 3. That the real estate described in Sections 1 and 2 of this Ordinance is hereby annexed to the City of Lexington, and the Corporate limits of said City are hereby extended to include all of said real estate within the boundaries of said City.

Section 4. That a certified copy of this Ordinance shall be filed and recorded in the office of the Register of Deeds of Dawson County, Nebraska.
