REVISION ORDINANCE NUMBER 758

An Ordinance of the City of Lexington, Dawson County, Nebraska, revising all the ordinances of the city; authorizing the publication thereof in book form; prescribing the time when such Ordinance shall become effective and repealing all ordinances in conflict

BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA.

Section 1. That all ordinances of a general and permanent nature comprising the Municipal Code of the City of Lexington, Nebraska, are hereby revised, compiled, codified and authorized to be published in book form with Table of Contents, under the direction and by authority of the President of the Council and Council of the said city.

Section 2. Such revision shall be classified under thirteen chapters entitled:

Chapter 1 - GOVERNMENT, ORGANIZATION Chapter 2.- PURCHASES, CONTRACTS, SALES Chapter 3 - REVENUE AND TAXATION

Chapter 4 - LICENSES AND PERMITS

Chapter 5 - BUSINESSES AND OCCUPATIONS
Chapter 6 - AMUSEMENTS, PARKS AND RECREATION
Chapter 7 - MISDEMEANORS, MORAL, CONDUCT
Chapter 8 - HEALTH, SAFETY AND SANITATION

Chapter 9 - VEHICLES, TRAFFIC AIRPLANES
Chapter 10- STREETS, ALLEYS AND SIDEWALKS
Chapter 11- ZONING AND PLANNING
Chapter 12- BUILDINGS AND SIGNS
Chapter 13-PUBLIC UTILITIES

Subdivided into Articles and Sections and in words and figures as follows:

In construing the provisions of this Revision Ordinance the following ordinances shall not be deemed or held to be ordinances of a general or permanent nature, to-wit: Ordinances pertaining to Fiscal Management, cacating streets or alleys, authorizing or directing public improvements, levying taxes or special assessments, annual budgets, granting franchises, any ordinance which by its nature would be considered special.

Section 4. Each chapter, article, and section hereof is here-by declared to be independent of every other chapter, article or section, and the invalidity of any chapter, article or section of this ordinance shall not invalidate any other chapter, article or section.

Section 5. All ordinances, or parts of ordinances in conflict werewith are hereby repealed.

Section 6. The repeal of ordinances as provided by Section t hereof, shall not affect any rights, fines, penalties, forfeitures or liabilities incurred or acquired thereunder, or actions involving any of the provisions of such ordinances, or any part thereof, and said ordinances are hereby continued in full force and effect after the passage, approval and publication of this revision for the purpose of such rights, fines, penalties, forfeitures and liabilities or actions thereunder liabilities or actions thereunder.

Section 7. This revision ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
