

ORDINANCE NO. 958

AN ORDINANCE CREATING IMPROVEMENT DISTRICT NO. 96 AND PROVIDING FOR CURB, GUTTER, GRAVEL, GRADING, DRAINAGE AND CONCRETE PAVING THEREIN.

BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA.

SECTION 1. That there is hereby created within the City an Improvement District to be known as "IMPROVEMENT DISTRICT NO. 96".

SECTION 2. That the said Improvement District shall consist of that part of West 12th Street from Johnson Street to Adams Street; That part of East 15th Street from Jefferson Street to Tyler Street; That part of Tyler Street from 5th Street to 4th Street; That part of 10th Street from Madison Street to Harrison Street; That part of 9th Street from Lincoln Street to Madison Street; That part of 15th Street from Washington Street to Madison Street; That part of 15th Street from Washington Street to Grant Street; That part of 12th Street from Madison Street to Harrison Street; That part of Tyler Street from 6th Street to 7th Street; That part of Madison Street from 16th Street to 17th Street and that part of Taylor Street from 6th Street to 7th Street; and the property abutting and adjacent thereto and benefited thereby, as by law provided.


SECTION 3. That there shall be constructed and provided on that part of West 12th Street from Johnson Street to Adams Street; That part of East 15th Street from Jefferson Street to Tyler Street; and That part of Tyler Street from 5th Street to 4th Street; curb, gutter, gravel, grading and drainage as needed, and that the curb, gutter, gravel, grading and drainage shall be in accordance with plans, specifications and estimates to be hereafter adopted. That there shall be constructed and provided on that part of 10th Street from Madison Street to Harrison Street; That part of 9th Street from Lincoln Street to Madison Street; That part of 15th Street from Washington Street to Madison Street; That part of 15th Street from Washington Street to Grant Street; That part of 12th Street from Madison Street to Harrison Street; That part of Tyler Street from 6th Street to 7th Street; That part of Madison Street from

16th Street to 17th Street and That part of Taylor Street from 6th Street to 7th Street concrete paving, grading and drainage as needed, and that the concrete paving, grading and drainage shall be in accordance with plans, specifications and estimates to be hereafter adopted.

SECTION 4. That the streets provided in the above section will abut on concrete paving or curb and gutter already laid.


SECTION 5. That the cost of such curb, gutter, gravel, grading, drainage and concrete paving except street and alley intersections, shall be assessed against the lots and tracts of land abutting upon and adjacent to the said portion of streets, specifically benefited thereby, in proportion to the benefits received, to be determined by the City Council as by law provided.
