ORDINANCE NO. 1109

AN ORDINANCE CREATING IMPROVEMENT DISTRICT NO. 135 AND PRO-VIDING FOR CURB, GUTTER, GRAVEL AND GRADING THEREIN.

BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA:

SECTION 1. That there is hereby created within the City an Improvement District to be known as "IMPROVEMENT DISTRICT NO. 135 ."

SECTION 2. That the said Improvement District shall consist of that portion of East 14th Street from Jefferson to Monroe, that part of 16th Street from Tyler Street to Monroe Street, that part of South Harrison Street from Vine Street to High Street and Harrison Street from Cedar Street to Oak Street, and the property abutting and adjacent thereto and benefited thereby, as by law provided.

SECTION 3. That there shall be constructed and provided on that portion of East 14th Street from Jefferson to Monroe, that part of 16th Street from Tyle r Street to Monroe Street, that part of South Harrison Street from Vine Street to High Street and Harrison Street from Cedar Street to Oak Street, curb gutter, gravel and grading as needed; that the curb, gutter, gravel and grading shall be in accordance with plans, specifications and estimates to be hereafter adopted.

SECTION 4. That the street provided in the above section will abut on concrete paving or curb and gutter already laid.

SECTION 5. That the cost of such curb, gutter, and gravel, and grading except street and alley intersections, shall be assessed against the lots and tracts of land abutting upon and adjacent to the said portion of streets, specifically benefited thereby, in proportion to the benefits received to be determined by the City Council as by law provided.

NOTICE OF CREATION OF AN IMPROVEMENT DISTRICT NO. 135 ORDINANCE NO. 1109

Notice is hereby given that the President of the Council and the City Council of the City of Lexington, Nebraska, have by Ordinance No. 1109 created Improvement District No. 135, consisting of the following described streets: That portion of East 14th Street from Jefferson to Monroe, that part of 16th Street from Tyler Street to Monroe Street, that part of South Harrison Street from Vine Street to High Street and Harrison Street from Cedar Street to Oak Street.

Unless written objections thereto are filed with The City Clerk within twenty days after December 1, 1966, as by law provided the President of the Council and City Council will proceed with the construction of curb, gutter, gravel and grading on that portion of East 14th Street from Jefferson to Monroe, that part of 16th Street from Tyler Street to Monroe Street, that part of South Harrison Street from Vine/from Cedar Street to Oak Street. Said construction in said district shall be in accordance with Ordinance No. 1109 above referred to and the costs thereof except street and alley intersections shall be assessed to the abutting and adjacent property of said district as by law provided, specifically benefited thereby in proportion to benefits received.
