ORDINANCE NO. 1184

AN ORDINANCE AMENDING SECTIONS 7-601 and 9-204.08 OF THE MUNICIPAL CODE OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA, AND PROVIDING FOR TEMPORARY USE OF SIDEWALKS AND STREETS FOR DISPLAY AND SALE OF MERCHANDISE AND TO PERMIT CIVIC GROUPS THE USE OF SIDEWALKS AND STREETS FOR PARADES AND OTHER CIVIC AND NON-PROFIT ENTERPRISES AND AMENDING ALL ORDINANCES AND SECTIONS OF THE SAID CODE IN CONFLICT WITH THIS ORDINANCE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. That Section 7-601 of the Municipal Code of the City of Lexington be and it hereby is amended to read as follows:

"7-601 MISCELLANEOUS OFFENSES - Obstructing Streets. Any person or persons, firm or corporation with the corporate limits of said City, who shall erect, or cause to be erected, any doorstep, or stairway which projects beyond the line of any lot or grounds lying upon any street, avenue or alley and over and upon such street or alley, or any shed or structure of any kind extending from any building upon any street, alley or sidewalk, or any signboard or post projecting over any street, alley or sidewalk to the annoyance or inconvenience of the public; or shall leave or place, or permit to be left or placed, in any street or alley or on any sidewalk, any wagon, cart, dray or carriage or other vehicle, or any wood, stone, brick, earth, hay, straw, or any other article or thing, whatsoever, in such manner as to obstruct or interfere in any manner with the public use of said street, alley or sidewalk or any part thereof, or place or leave, or permit to be placed or left, on any street, alley or sidewalk, any boards, hoops, nails, hoop-iron, crockery, glass, paper, ashes or rubbish, whatsoever, or burn any of the same on any street, alley or sidewalk so as to obstruct or impede the public use thereof, or so as to obstruct any gutter or water course of said street or alley, except as otherwise provided in Section "9-204.08", shall be guilty of a misdemeanor, and on conviction

thereof shall be fined in any sum not less than One Dollar (\$1.00) nor more than Fifty Dollars (\$50.00), together with all costs of prosecution, and shall stand committed to jail until such fine and costs are fully paid; and each day any such obstruction shall be allowed to continue after such conviction shall constitute a distinct and separate offense."

Section 2. Section 9-204.08 be and the same is hereby amended to read as follows:


"9-204.08 TRAFFIC - Parking, Display of Merchandise on Streets and Sidewalks Prohibited. No vehicles, machinery or other articles of merchandise shall be displayed for sale on the streets, or sidewalks of said City, and no vehicle of any kind shall be parked on any street of said City where limited parking is not in effect for a period of time in excess of 24 hours, except as follows:

(a) The City Manager may permit the use of sidewalks to all merchants for display of merchandise for not to exceed two times a year and not to exceed two days at any one time.


(b) The City Manager may permit a temporary use of streets and sidewalks to civic groups and non-profit organizations and other civic and non-profit enterprises."

Section 3. That any parts of existing Codes or any parts of existing Ordinances in conflict hereto, be and the same are hereby repealed.
