ORDINANCE NO. 1417

AN ORDINANCE OF THE CITY OF LEXINGTON TO LIMIT THE TIME OF PARKING MOTOR VEHICLES WITHIN OR ON STREETS ADJOINING THE BOUNDARIES OF THE VEHICLE OFF-STREET PARKING DISTRICT NO. 1; TO PROVIDE FOR CHANGE THEREOF; TO PROVIDE FOR VIOLATION THEREOF; TO ESTABLISH A VIOLATIONS BUREAU FOR THE HANDLING OF NON-MOVING TRAFFIC VIOLATIONS; TO PROVIDE FOR FEES FOR SAID VIOLATIONS AND THE COLLECTION AND ENFORCEMENT OF SAME; TO DEFINE NON-MOVING TRAFFIC VIOLATIONS; TO REPEAL SECTIONS 16-50(b), 16-54, 16-55, 16-56, 16-57, 16-58, 16-59, 16-60, 16-61, 16-62, 16-63, 16-64, AND ALL ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR PUBLICATION AND EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND COUNSEL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. TIME LIMIT. It shall be unlawful for any person to park any motor vehicle along the curb on either side of the street or in the off-street parking lots that are within or adjoining the boundaries of the Vehicle Off-Street Parking District No. 1 of the City created by Ordinance No. 1390, for a period of time in excess of two consecutive hours between the hours of 8:00 A.M. and 5:00 P.M., except Thursday, which shall be between the hours of 8:00 A.M. and 9:00 P.M., provided, two hour parking shall be located in the same areas where parking meters were located at the time of adoption of Ordinance No. 1390 on August 20, 1975. This two hour parking limitation shall not apply to all day Sunday and all legal holidays. This two hour parking limitation shall not apply to any area within the parking district that is properly designated with the proper parking time limit signs for other than two hours parking as approved by the City Council. The two hour parking area shall be properly designated by parking time limit signs and there shall be filed with the City Clerk a map of the parking time limit areas within and adjoining the Off-Street Parking District No. 1, kept continuously current and available for public inspection.

Section 2. METHOD OF CHANGING PARKING TIME LIMIT AREAS.

Any change to the parking time limit areas within and joining the Off-Street Parking District No. 1, may be made by Resolution of the Council and by changing the parking time limit signs affected. Likewise, the map filed with the City Clerk shall be updated to reflect the change.

Section 3. METHOD OF NOTICE. Violators of the two

hour parking limitation provided herein, shall be given notice in the form of an official police tag attached to the offending motor vehicle which notice shall require such violators to appear forthwith at the Violations Bureau. If such violator shall fail to appear in response to such notice within a period of five days, the violator shall be liable to prosecution and subject to penalties set forth in Section 1.7 General Penalty, of this Code, and the Violations Bureau shall cause a complaint and warrant to be filed against such violator who fails to comply with the procedure set forth herein.

Section 4. PENALTY. Any violator appearing herein

prior to the day of filing a complaint and warrant of arrest, desiring to plead guilty and waive Court appearance shall sign a written guilty plea and waive the Court appearance and shall pay to the Violations Bureau the sum of \$2.00; \$1.00 which shall be assessed as a fine, and \$1.00 of which shall be assessed as a fee covering costs of administration.

Section 5. VIOLATIONS BUREAU. There is hereby es-

tablished a Violations Bureau within the City of Lexington, Nebraska, for the handling of non-moving traffic violations as hereinafter defined. The Lexington Police Department shall be the office of the Violations Bureau, and shall collect all fines and fees for such violations and remit such fees monthly to the City Treasurer of Lexington, Nebraska, and remit such fines to the Treasurer of Lexington School District.

Section 6. NON-MOVING TRAFFIC VIOLATIONS - DEFINED.

Non-Moving traffic violations are hereby defined as all violations of the two hour parking limitation set forth in Section "1" in this Ordinance.

Section 7. ENFORCEMENT. The enforcement of this Or-

dinance and violation of the provisions thereof shall be under the police jurisdiction of the City of Lexington, Nebraska, and its duly designated officers.

Section 8. Sections 16-50(b), 16-54, 16-55, 16-56,


16-57, 16-58, 16-59, 16-60, 16-61, 16-62, 16-63, 16-64, and all other ordinances and parts of ordinances in conflict herewith shall be, and the same are repealed.

Section 9. This Ordinance shall be published in pamphlet

form and take effect as provided by law.
