ORDINANCE NO. 1431

AN ORDINANCE CREATING SANITARY SEWER EXTENSION DISTRICT NO. 79 OF
THE CITY OF LEXINGTON, NEBRASKA; ESTABLISHING THE OUTER BOUNDARIES OF THE DISTRICT;
DESIGNATING THE SIZE, LOCATION AND TERMINAL POINTS AND REFERRING TO THE PLANS AND
SPECIFICATIONS AND ESTIMATE OF THE ENGINEER IN CONNECTION THEREWITH ON FILE WITH
THE CITY CLERK; AND ORDERING THE ORDINANCE PUBLISHED IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. The President and Council of the City of Lexington, Nebraska, hereby find and determine that it is necessary and advisable to extend sanitary sewer service to and beyond the existing system by the construction of sanitary sewer mains, and for the purpose of constructing said sewer mains there is hereby created Sanitary Sewer Extension District No. 79 of the City.

Section 2. The outer boundaries of the Sanitary Sewer Service District No. 79 in which it is proposed to make special assessments shall include all of the following described property, to wit:

Lots 11 thru 16 of Block 6; Lots 3 thru 8 of Block 5; Lots 3 thru 8 of Block 4, and Lots 3 thru 8 of Block 3 in Woodwards 2nd Addition.

Section 3. The size and location, and terminal points of the sanitary sewer main in said district is as follows; to wit-:

Extension of an 8" vitrified clay tile sewer main in the easements in Block 3,4,5 and 6 to service all lots within the above described boundaries.

Section 4. It is hereby found and determined that none of the above property is located more than one mile from the City limits and the lots and lands included in Sanitary Sewer Extension District No. 79 of Lexington, Nebraska, are located apart and outside any area served and benefited by the existing Sanitary Sewer System.

Section 5. Reference is hereby made to plans and specifications for the sewer extension which have been prepared by the City Engineer, by order of the President and Council of the City pursuant to a Resolution duly passed by the Council in which, together with the Engineer's estimate of the total cost of the proposed extension, have heretofore been filed with the City Clerk.

Section 6. The Engineer's estimate of the total cost of the project for Sanitary Sewer Extension District No. 79 is as follows: \$12,683.55

Section 7. This Ordinance shall be published in pamphlet form and take effect as provided by law.
