## ORDINANCE NO. <u>1521</u> THE ANNUAL APPROPRIATION BILL

AN ORDINANCE APPROPRIATING MONEY OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA, FOR THE PURPOSE OF PAYING LIABILITIES, EXPENSES, AND FOR NECESSARY IMPROVEMENTS FOR THE FISCAL YEAR BEGINNING THE 1st DAY OF AUGUST, 1977, AND ENDING THE 31st DAY OF JULY, 1978.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, IN NEBRASKA:
