## ORDINANCE NO. 1547

AN ORDINANCE VACATING LOTS ONE (1) THROUGH EIGHT (8); LOTS ELEVEN (11) THROUGH EIGHTEEN (18); ROOSEVELT STREET BETWEEN THE NORTH LINE OF LOT TEN (10) TO THE SOUTH LINE OF 20th STREET; THE ALLEY LYING ON THE EAST LINE OF LOTS ONE (1) THROUGH NINE (9) BETWEEN THE NORTH LINE OF LOT NINE (9) AND THE SOUTH LINE OF 20TH STREET; AND THE EAST FORTY-FOUR AND ONE HUNDRETHS (44.01) FEET OF 20TH STREET LYING WEST OF THE EAST LINE OF THE SOUTHWEST QUARTER OF SECTION THIRTY-TWO (32), TOWNSHIP TEN (10) NORTH, RANGE TWENTY-ONE (21) WEST OF THE SIXTH P.M., ALL IN ROSE PARK ADDITION TO THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA, REPEALING ALL ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. WHEREAS, all of the owners of lots and lands thereto have requested the vacation of Lots One (1) through Eight (3); Lots Eleven (11) through Eighteen (18); Roosevelt Street between the North line of Lot Ten (10) to the South line of 20th Street; and the alley lying on the East line of Lots One (1) through Nine (9) between the North line of Lot Nine (9) to the South line of 20th Street; and the East forty-four and one hundreths (44.01) feet of 20th Street lying West of the East line of the Southwest quarter of Section Thirty-two (32), Township Ten (10) North, Range Twenty-one (21) West of the Sixth P.M. all in Rose Park Addition to the City of Lexington, Dawson County, Nebraska, and the City Council deems it advantageous and best for the interest of the City to vacate the same, now, therefore,

Section 2. Lots One (1) through Eight (8); Lots Eleven (11) through Eighteen (18); Roosevelt Street between the North line of Lot Ten (10) to the South line of 20th Street; the alley lying on the east line of Lots One (1) through Nine (9) between the North line of Lot Nine (9) to the South line of 20th Street; and the East forty-four and one hundreths (44.01) feet of 20th Street lying West of the East line of the Southwest quarter of Section Thirty-two (32), Township Ten (10) North, Range Twenty-one (21) West of the Sixth P.M., all in Rose Park Addition to the City of Lexington, Dawson County, Nebraska, is hereby wholly vacated and shall no longer be or constitute a part of the City of Lexington, Nebraska, and the ownership of all streets and alleys therein shall revert to the owners of lots and lands abutting the same in proportion to their

respective ownerships of such lots or grounds.

Section 3. All of the sections or parts of sections in conflict herewith are repealed.

Section 4. This Ordinance shall be published in pamphlet form and take effect as provided by law.
