ORDINANCE NO. 1582

AN ORDINANCE CREATING IMPROVEMENT DISTRICT NO. 223 IN THE CITY OF LEXINGTON, NEBRASKA, ORDERING THE CONSTRUCTION OF STREET IMPROVEMENTS THEREIN, AND ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, as follows:

Section 1. That there be and hereby is created in the City of Lexington, Nebraska, an improvement district to be known and designated as Improvement District No. 223 of the City of Lexington, Nebraska.

Section 2. That the outer boundaries of Improvement District No. 223 include, in addition to the street to be improved, all of the following described property, to-wit:

The west 629.5' of Lot 23 north of 7th Street and all of Lot 23 south of 7th Street of the subdivision of Tract C in the east 1/2 of Section 6-9-21; the west 520' of Block L south of 7th Street and all of Tract K of the subdivision of the east 1/2 of Section 6-9-21; and all of Block 29, the south 1/2 of Blocks 30 and 31 and all of Block 33 in MacColl and Leflang's Second Addition; the south 1/2 of Blocks 52 and 53, all of Block 63, the south 1/2 of Block 62 and all of Block 64 in the original Town of Plum Creek; all of Block 19 in MacColl and Leflang's Third Addition; all of Lots 1 and 2 of Block F of the subdivision of Section 5-9-21; the north 150' of Union Pacific Railroad right-of-way abutting U. S. Highway No. 30 between the west line of Erie Street and the east line of Taft Street, all in the City of Lexington, Dawson County, Nebraska.

and within which district the following street shall be improved by grading, concrete paving and drainage.

U. S. Highway No. 30 from the west line of Erie Street to the east line of Taft Street.

Section 3. Said street shall be improved and said improvements shall be made in accordance with the plans, specifications and estimate prepared by the special engineer employed by the City and to be approved by the Mayor and Council.

Section 4. Notice of the creation of said District shall be

published as provided by law in the Lexington Clipper,

a legal newspaper of the City of Lexington, Nebraska.

Section 5. This ordinance shall be published in pamphlet form and take effect as provided by law.
