

RESOLUTION NO. 1584

A RESOLUTION SETTING ELECTRICAL RATES FOR ALL USER CLASSIFICATIONS  
IN ACCORDANCE WITH ORDINANCE NO. 1583.

WHEREAS, the City Council of Lexington, Nebraska has passed Ordinance  
No. 1583 effective February 28, 1978 and

WHEREAS, Ordinance No. 1583 provides that the electrical rates shall  
be set by Resolution by the City Council for all user classifications,

NOW, THEREFORE, be it resolved by the City Council of Lexington, Ne-  
braska that the following electrical rates for the following user classifications  
are established and shall be effective on : February 28, 1978 and shall con-  
tinue to be effective until revised.

Residential  
(All Residential Use)

Over 1500 KWH/month @	2.7¢	1.15¢

Plus Production Cost Adder Charge and Sales Tax

Minimum charge \$5.00

Summer Rate effective May through September

Winter Rate effective October through April

Business - Small

First 100 KWH/month @	11.25¢/KWH
Next 400 KWH @	5.25¢
Next 500 KWH @	4.25¢
Next 2000 KWH @	3.25¢
Next 7000 KWH @	2.75¢
Over 10,000 KWH @	2.55¢

Plus Production Cost Adder Charge and Sales Tax

Minimum Charge \$8.00

Business - Large

Base Charge of	\$22.50/month
Plus First 100 KWH/month @	3.65¢
Next 200 KWH @	1.8¢
Excess @	1.5¢

Plus Production Cost Adder and Sales Tax

Minimum charge 2.00/KW of Highest Demand in previous 12 months (not less than \$45.00)

Business - Heating

First 500 KWH/month @	5.2¢
Next 500 KWH @	2.7¢
Next 4,000 KWH @	1.4¢
Over 5,000 KWH @	1.2¢

Plus Production Cost Adder and Sales Tax

Minimum charge in heating season \$15.00

Heating season - October through April

Industrial

Base Charge of	\$35.00/month
Plus First 100 KWH/KW/month @	3.55¢
Next 100 KWH/KW @	1.85¢
Next 150 KWH/KW @	1.45¢
Excess	1.2¢

Plus Production Cost Adder and Sales Tax

Minimum Charge \$2.00/KW of Highest demand in previous 12 months (not less than \$125.00)

Seasonal Irrigation

Billing to be at appropriate business rate

Yard Light Service

Monthly charge per unit	Metered Use	Unmetered
175 watt unit	\$3.25	\$4.40
250 watt unit	3.80	5.30
400 watt unit	4.35	6.80

Municipal - Street Lighting

Base Charge of	\$900/month
Plus energy @	1.55¢/KWH
Plus Production Cost Adder	

Municipal - Light and Power

Base Charge of	\$3.50/month/meter
Plus energy @	2.1¢/KWH
Plus Production Cost Adder	

Production Cost Adder Charge

Any production cost adder charged to the city by it's supplier shall be assessed to all users at the same rate per KWH times a factor of 1.1.
