

ORDINANCE NO. 1639  
THE ANNUAL APPROPRIATION BILL

AN ORDINANCE APPROPRIATING MONEY OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA, FOR THE PURPOSE OF PAYING LIABILITIES, EXPENSES, AND FOR NECESSARY IMPROVEMENTS FOR THE FISCAL YEAR BEGINNING THE 1ST DAY OF AUGUST, 1979, AND ENDING THE 31ST DAY OF JULY, 1980.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. That there is hereby appropriated out of money to be raised by a general levy of taxes upon all property within the City of Lexington, Nebraska, and of money now on hand and other revenue available for the purpose of paying liabilities, current expenses and for necessary improvements and expenses of said City, for the fiscal year 1979-80, the following sum of money, to-wit:
