

AN ORDINANCE CREATING IMPROVEMENT DISTRICT NO. 230 PROVIDING FOR GRADING, ASPHALTIC CONCRETE PAVING AND DRAINAGE THEREIN; AND ORDERING THE ORDINANCE PUBLISHED IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA.

Section 1. There is hereby created within the City of Lexington, Improvement District to be known as "Improvement District No. 230".

Section 2. The Improvement District shall consist of the following streets or portions of streets in the City of Lexington, Nebraska:

Adams Street from Walnut Street to South City Limits on North Right-of-Way of Drainage District No. 1. Beginning at the Northwest Corner of Section Eight (8), Township Nine (9), Range Twenty-One (21); thence East One Hundred, Eighty-Two and Six Tenths Feet (182.6'); thence South and parallel to the East Right-of-Way line of Adams Street a distance of One Thousand, Six Hundred, Sixty-three and Five Tenths Feet (1,663.5') to a point on the North line of Southaven Addition; thence East Six and Sixty-one Hundredths Feet (6.61') to the Northeast corner of Lot Two (2), Block Two (2), Southaven Addition; thence South One Hundred and Forty Feet (140'); thence West Thirty-nine and Thirty-six Hundreths Feet (39.36'); thence South and along the West line of Lots One (1) through Five (5), Block One (1), Southaven Addition, a distance of Four Hundred, Seven and Forty-four Hundreths Feet (407.44'); thence East Twenty-nine and Ninety-nine Hundreths Feet (29.99'); thence South One Hundred Seventy and Sixty-nine Hundreths Feet (170.69') to a point on the South City Limits, being the Southeast corner of Lot Two (2), Block Eight (8), Southaven Addition; thence West One Hundred and Eighty Feet (180') to the West line of Section Eight (8); Township Nine (9), Range Twenty-one (21); thence North along said Section line One Thousand, Thirty-four and Eight Tenths Feet (1,034.8'); thence West One Hundred, Eighty-Four Feet (184'); thence North One Thousand, Three Hundred, Seventy-two and Seventy-Six Hundreths Feet (1,372.76') to the North Section line of Section Seven (7), Township Nine (9), Range Twenty-One (21); thence East One Hundred, Eighty-three Feet (183') to the point of beginning.

Section 3. There shall be constructed and provided on the above described streets, grading, paving and drainage which shall be in accordance with the plans, specifications, and estimates to be hereinafter adopted.


Section 4. The streets provided in the above section will abut on curb and gutter where it exists.

Section 5. That the cost of such grading, paving and drainage except street and alley intersections, shall be assessed against lots and tracts of land abutting upon and adjacent to said portion of the streets, specifically

benefited thereby, in proportion to the benefit received, to be determined by the City Council as the law provides.


Section 6. This Ordinance shall be published in pamphlet form and take effect as provided by law.
