

ORDINANCE NO. 1670

AN ORDINANCE CREATING SANITARY SEWER CONNECTION DISTRICT NO. 92, AND PROVIDING FOR THE CONSTRUCTION OF A SANITARY SEWER MAIN THEREIN; TO PROVIDE FOR THE REPEAL OF ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM AND AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. That there is hereby created within the City a Sanitary Sewer Connection District as provided for by Section 16-6, 102 R.R.S. 1943, to be known as Sanitary Sewer Connection District No. 92, consisting of property described as follows, to-wit:

Beginning at the Northeast corner of Block One (1), Grand Prairie Addition to the City of Lexington, Dawson County, Nebraska; thence West along the South line of 13th Street for a distance of Nine Hundred Feet (900'); thence South 0° 42' East a distance of Six Hundred Feet (600'); thence East a distance of One Hundred Fifty Feet (150'); thence South 0° 42' East a distance of Two Hundred Eighty Four and Five/Tenths Feet (284.5') to a point on the North Line of Buffalo Bend Street; thence Northeasterly along the North Line of Buffalo Bend Street a distance of Four Hundred Ninety One and Three/Tenths Feet (491.3') to a point which is the Southwest corner of Block One (1) Grand Prairie Addition; thence East along the North Line of Buffalo Bend a distance of Forty Feet (40'); thence North 0° 42' West a distance of Two Hundred Ninety Feet (290'); thence West a distance of Three Hundred Feet (300'); thence North 0° 42' West a distance of Three Hundred Six and Six/Tenths Feet (306.6'); thence East a distance of Five Hundred Sixty Feet (560') to a point on the West line of Erie Street; thence North 0° 42' West along the West line of Erie Street a distance of One Hundred Fifty Feet (150') to the point of beginning.

Section 2. That a Sanitary Sewer Main shall be constructed of Eighteen (18) inch and Eight (8) inch vitrified clay and reinforced concrete pipe, to be laid within the street right-of-way of West 13th Street from Erie to Freedom Lane and across Tri-County Hospital property.

Section 3. That a part of the cost of said Sanitary Sewer main as determined by the City Council, sitting as a board of equalization, shall not be levied as special assessments against the property within the district, but shall be paid for by a connection fee in the amount of the benefit occurring to the property in the district at the time such property becomes connected to the sewer main.

Section 4. That all ordinances or sections of ordinances in conflict herewith are hereby repealed.

Section 5. That this ordinance shall be published in pamphlet form and take effect as provided by law.


