AN ORDINANCE TO PROVIDE FOR LAW ENFORCEMENT IN PRIVATE PARKING LOTS; TO PROVIDE PARKING AND TRAFFIC REGULATIONS ON PRIVATE PARKING LOTS; TO PROHIBIT TRESPASS IN PRIVATE PARKING LOTS AND PROVIDE A PENALTY THEREFOR; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM AND EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

Section 1. It is specifically found to be in the public interest of the City of Lexington, and in the interest of maintaining the public peace and traffic control that provision be made for regulation of the use of privately owned parking lots.

Section 2. Upon written request made to the Chief of Police, and a copy to be filed with the City Clerk, the City Police Department is hereby authorized to patrol upon and enforce the ordinances of the City of Lexington and the laws of the State of Nebraska relating to trespass, use of alcohol, and morals, upon privately owned parking lots within the City of Lexington.

Section 3. Upon written request by the owner of such private parking lot, subject to approval by the Chief of Police, and subject to posting of appropriate signs by the lot owner, traffic control regulations for such parking lot shall be established.

Section 4. Upon written request of the owner of such private parking, subject to approval by the Chief of Police, and upon appropriate signs being posted, restricted parking rules shall be enforced. The term "restricted parking" shall include restrictions in regard to time, place, and manner of parking or of persons authorized to part.

Section 5. Any person who shall violate any of the provisions of the foregoing ordinance, or any provisions of the parking or traffic regulations established under the terms of this ordinance, shall be punished as provided in Section 1-7 of the Lexington City Code.

Section 6. All ordinances or sections of ordinances in conflict herewith are hereby repealed.

Section 7. This ordinance shall be published in pamphlet form and take effect as provided by law.
