Deputy ORDINANCE NO. 1835

AN ORDINANCE TO VACATE THAT PORTION OF BLOCK FOUR (4) OF STEVEN'S ADDITION TO THE CITY OF LEXINGTON, NEBRASKA, WHICH WAS USED FOR A CITY WATER WELL; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

Section 1. The City of Lexington hereby determines that the property dedicated to the City of Lexington in Block Four (4) of Steven's Addition to the City of Lexington, Nebraska, is no longer used for a water well, and that it is advantageous and for the best interests of the City that said property be vacated.

Section 2. That the following described property, to-wit:

A tract of land in Block Four (4), Steven's Addition to the City of Lexington, Dawson County, Nebraska, reserved for well purposes, and more specifically described as follows: Beginning at the Northeast Corner of Lot Eleven (11), Block Four (4), Steven's Addition; thence East Thirty Feet (E30') to the Northwest Corner of Lot Twelve (12), Block Four (4); thence South Forty-Five Feet (S45'); thence West Thirty Feet (W30'); thence North Forty-Five Feet (N45') to the point of beginning; except, however, for a reserved utility easement upon the East Sixteen Feet (E16') of said tract:

is hereby vacated and shall revert to the owner or owners of lots or lands abutting the same in proportion to the respective ownership of such lots or grounds.

Section 3. That all other ordinances or sections of ordinances in conflict herewith are hereby repealed.

Section 4. That this ordinance shall be published in pamphlet form and take effect as provided by law.
