ORDINANCE NO. 1839

AN ORDINANCE TO AMEND THE ZONING CODE OF THE CITY OF LEXINGTON, TO PROVIDE PROVISIONS FOR KENNELS AND CATTERIES; TO AMEND SECTION 28-9 and 28-23 OF THE ZONING CODE; TO REPEAL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

Section 1. That Section 28-9 of the Lexington City Code is hereby amended to provide for the <u>addition</u> of the following:

CATTERY. The ownership, harboring or maintenance of more than four (4) domestic cats on the premises of a zoned lot, whether kept for private or business purposes; provided, that on a farm, "domestic cats" shall include only those kept as household pets.

KENNEL. The ownership or harboring of more than four (4) dogs on the premises of a zoned lot, whether kept for private or business purposes.

Section 2. That Section 28-23 of the Lexington City Code shall be amended to read as follows:

Section 28-23. Special uses zone districts.

The following uses shall be allowed with special use permits.
