ORDINANCE NO. 1880

AN ORDINANCE TO AMEND THE ZONING MAP OF THE CITY OF LEXINGTON, NEBRASKA; TO REZONE THE PROPERTY DESCRIBED IN THE ATTACHED
PLAT FROM A-1 (Agricultural) and A-2 (Urban Reserve) TO RP-3
(Planned Multi-Family Residential); TO PROVIDE FOR AN EFFECTIVE
DATE AND PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

Section 1. That the zoning map of the City of Lexington, Nebraska, is hereby amended to change from A-1 (Agricultural) and A-2 (Urban Reserve) to RP-3 (Planned Multi-Family Residential) the property owned by Tri-County Hospital and described as follows:

A Tract of land in the Northwest Quarter of Section 6, Township 9 North, Range 21, West of the 6th P.M., Dawson County, Nebraska, and more particularly described as follows:

Referring to the North One-Quarter Corner of Section 6, Township 9 North, Range 21, West of the 6th P.M., Dawson County, Nebraska;

Thence West (an assumed bearing), and along the North Line of the Northwest Quarter of said Section 6, a distance of 521.6 feet;

Thence S 0°42'27" W, a distance of 391.71 feet, to the Point of Beginning;

Thence S 89°05'26" E, a distance of 213.7 feet;

Thence North, a distancé of 79.3 feet;

Thence East, a distance of 81.9 feet;

Thence South, a distance of 121.6 feet;

Thence N 89°19'00" W, a distance of 107.0 feet;

Thence S 0°40'00" W, a distance of 353.34 feet to a point on the Northerly Right-of-Way of Buffalo Bend;

Thence Southwesterly on a 451.55 foot radius curve to the Left (the initial tangent of which forms an angle 74°16'48" Right from the last described course) a distance of 159.77 feet, to the point of tangency;

Thence Southwesterly on a 390 foot radius curve to the Right (the initial tangent of which coincides with the last described course), a distance of 245.12 feet;

Thence S 0°43'50" W, deflecting 90° Left from the final tangent of the last described course, a distance of 30.00 feet;

Thence Northwesterly on a 420.00 foot radius curve to the Right (the initial tangent of which forms an angle of 90° Right from the last described course), a distance of 505.29 feet:

Thence N 31°00' E, deflecting 51°20'20" Right from the final tangent of the last described course, a distance of 265.11 feet;

Thence N 76°30' E, a distance of 457.00 feet;

Thence S 0°42'27" W, a distance of 40.71 feet to the place of beginning.

Section 2. That this Ordinance shall be published in pamphlet form and take effect as provided by law.
