ORDINANCE NO. 2003

AN ORDINANCE TO ASSESS THE COST OF DESTRUCTION AND REMOVAL OF WEEDS AGAINST CERTAIN PROPERTY; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

Section 1: That pursuant to Section 16-230 of the Nebraska Revised Statutes, and Section 18-4 of the Lexington City Code, and after notice given as required by law, the City has removed and destroyed weeds and worthless vegetation growing upon the following described property, to-wit:

The East Twenty Feet (E 20') of Lot Four (4), and all of Lot Three (3), Block Nineteen (19), MacColl and Leflang's Second Addition to the Original Town of Plum Creek, now City of Lexington, Dawson County, Nebraska.

Section 2: That the cost incurred by the City for said destruction and removal of weeds is as follows:

Mowing:	\$ <u>100.00</u>
Administration:	\$ <u>100.00</u>
<b>TOTAL:</b>	\$ <u>200.00</u>

Section 3: That there be and hereby is levied and assessed against the above described real estate, a special tax of \$ 200.00 to pay the cost of mowing and removal of weeds as aforesaid, and that said assessment shall be due

and payable in full upon adoption of this Ordinance, and thereafter shall draw delinquent interest as provided by Section 45-104.01, R.R.S. 1943.

Section 4: That the City Clerk shall cause a copy of this Ordinance to be recorded in the office of the Register of Deeds of Dawson County, Nebraska.

Section 5: That this Ordinance shall be published in pamphlet form and take effect as provided by law.
