

ORDINANCE NO. 2187

AN ORDINANCE TO AMEND SECTION 16-41 OF THE LEXINGTON CITY CODE; TO PROVIDE FOR AMENDED SPEED LIMITS ON ADAMS STREET; TO REPEAL ORIGINAL SECTION 16-41, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA AS FOLLOWS:

Section 1. That Section 16-41 of the Lexington City Code is hereby amended to read as follows:

Sec. 16-41 Same—Other Specific Speed Limits.

- (a) The speed limit shall be thirty miles per hour on the following streets or parts of streets:
- Plum Creek Parkway and Jackson Street, Maple to Fifth Street
 - Fifth Street, Grant to Jefferson
 - Grant Street, Fifth Street to Pacific Avenue
 - Jefferson Street, Pacific Avenue to Fifth Street
- (b) The speed limit shall be thirty-five miles per hour on the following streets or parts of streets:
- Adams Street, from Drainage District No. 1 drainage ditch the City Limits north of 20th Street.
 - Pacific Avenue, 700 feet East of Monroe Street to 600 feet West of Adams Street.
 - Taft Street, Pacific Avenue to 13th Street.
 - West Walnut Street, Adams Street West to the City Limits.
 - East Walnut Street, Plum Creek Parkway East to the City Limits.
 - Cattlemen's Drive, Adams Street to Plum Creek Parkway;
 - East Industry Drive, Walnut Street to Prospect Road;
- (c) The speed limit shall be forty miles per hour on the following street or parts of street:

Bridge Street, Maple to 550' South of Sagebrush Lane.

(d) The speed limit shall be forty-five miles per hour on the following streets or parts of streets:

Pacific Avenue, East City Limits to 700 feet East of Monroe Street.

Pacific Avenue, 600 feet West of Adams to West City Limits.

Plum Creek Parkway, 550' South of Sagebrush Lane to South City Limits.

(e) The speed limit shall be 15 miles per hour in the school zone on the following street or part of street, while flashing lights are in operation:

Walnut Street, Lincoln Street to Madison Street;

West 13th Street, from the alley one-half block East of Harrison Street to the alley one-half block West of Harrison Street;

East 13th Street, from Tyler Street to Jefferson Street;

West 10th Street from Taylor Street to one-half block East of Harrison Street.

(f) The speed limit shall be 25 miles per hour in the school zone on the following street or part of street, while flashing lights are in operation:

Adams Street, one-half block south of 10th Street to one-half block north of 10th Street.

Section 2. That original 16-41, together with all ordinances or sections of ordinances in conflict herewith are hereby repealed.

Section 3. That this Ordinance shall be published in pamphlet form and take effect as provided by law.
