AN ORDINANCE TO DEDICATE PUBLIC RIGHT-OF-WAY; TO DECLARE AN EMERGENCY AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM.

WARRANTY DEED

A tract of land being the South 50.0 feet of the East 500.0 feet of the North Half of the Southwest Quarter (N1/2 SW1/4) of Section Seventeen (17), Township Nine (9) North, Range Twenty-one (21) West of the Sixth Principal Meridian, Dawson County, Nebraska, EXCEPTING HOWEVER, that part deeded to the State of Nebraska and more particularly described as follows: A tract of land being part of feet of the North Half of the Southwest Quarter (N1/2 SW1/4) of Section Seventeen (17), Township Nine (9) North, Range Twenty-one (21) West of the Sixth Principal Meridian, Dawson County, Nebraska, more particularly described as follows: Referring to the Southeast Corner of the North Half of the Southwest Quarter of said section; thence westerly along the South line of said North Half a distance of 155.01 feet; thence northerly deflecting 90°42'05" right to a point on the East line of said Southwest Quarter; thence southerly on the aforesaid East line a distance of 50.0 feet to the place of beginning.
