

RESOLUTION

A resolution requesting and authorizing either the County Assessor or the County Clerk to divide the levy of special assessments on the real estate herein described.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. The County Assessor or County Clerk of Dawson County, Nebraska, are hereby authorized and requested to divide and equalize the levy of special assessments for sewer improvements as hereinafter set forth:

SEWER DISTRICT NO. 25.

Lots Seven (7), Eight (8) and Nine (9), in Block Three (3), Stuckey and Little's Addition to the City of Lexington, to be divided as follows:

The South Half of Lots Seven (7) and Eight (8) in said Block Three (3). (Christina VanHorn) (One Third -1/3)

The North Half of Lots Seven (7) and Eight (8) in said Block Three (3). (John H. Day) (One Third -1/3)

All of Lot Nine (9), in said Block Three (3). (L. D. McCoy) (One Third -1/3)

SEWER DISTRICT NO. 31.

Lots One (1) and Two (2), in Block Four (4), MacColl and Leflang's Second Addition to the City of Lexington, Dawson County, Nebraska, to be divided as follows:

Lot One (1), in said Block Four (4). (Frank L. Lockhart and Elsie L. Lockhart) (One Half -1/2)

Lot Two (2), in said Block Four (4). (Leo Marick) (One Half -1/2)

SEWER DISTRICT NO. 32.

Lots Five (5) and Six (6), in Block Twelve (12), J. L. May's Addition to the City of Lexington, Nebraska, to be divided as follows:

Lot Five (5), in said Block Twelve (12). (Mary Watkins) (One Half -1/2)

Lot Six (6), in said Block Twelve (12). (Roy Clark) (One Half -1/2)

SEWER DISTRICT NO. 37.

Lots Seven (7), Eight (8) and Nine (9), in Block Two (2), James Ervin's First Subdivision to the City of Lexington, Nebraska, to be divided as follows:

- Lot Seven (7), in said Block Two (2).
- Lot Eight (8), in said Block Two (2). (One Third $-1/3$) (Don Kipp)
- Lot Nine (9), in said Block Two (2). (One Third $-1/3$) (Roy and Mae Barnes) (One Third $-1/3$)
