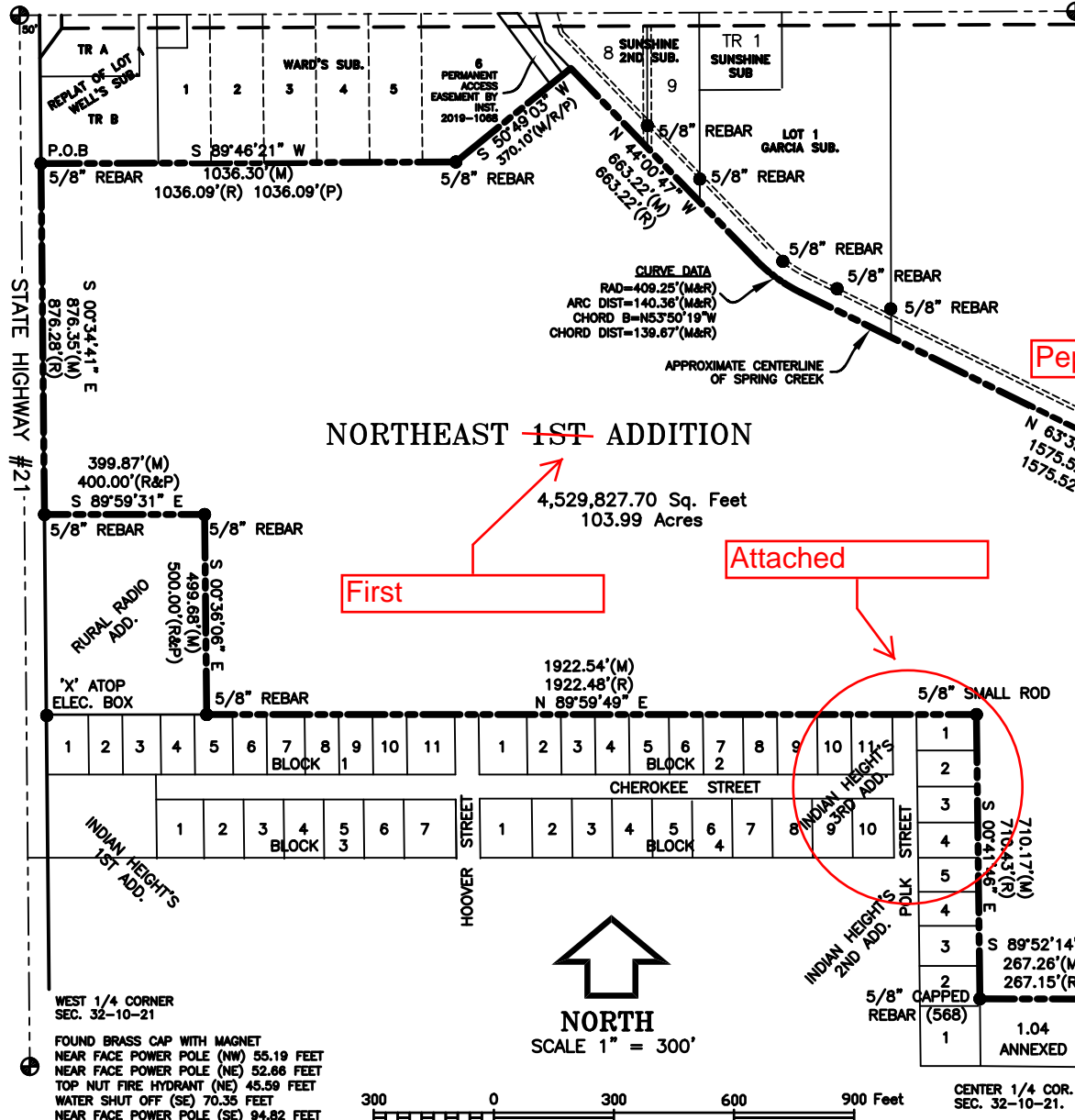

REFERRING TO THE NORTHWEST CORNER OF SECTION 32, TOWNSHIP 10 NORTH, RANGE 21 WEST OF THE SIXTH PRINCIPAL MERIDIAN, DAWSON COUNTY, NEBRASKA; THENCE EAST (AN ASSUMED BEARING) AND ALONG THE NORTH SECTION LINE OF SAID SECTION 32, A DISTANCE OF 50.00 FEET; THENCE SOUTH 0°21'00" EAST AND ALONG THE EASTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY NO. 21, A DISTANCE OF 370.78 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 0°21'00" EAST AND ALONG THE EASTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY NO. 21, A DISTANCE OF 876.28 FEET; THENCE SOUTH 89°47'15" EAST AND ALONG THE NORTHERLY LINE OF THE NEBRASKA RURAL RADIO ADDITION, A DISTANCE OF 400.00 FEET; THENCE SOUTH 0°21'00" EAST AND ALONG THE EASTERLY LINE OF THE NEBRASKA RURAL RADIO ADDITION, A DISTANCE OF 500.00 FEET; THENCE SOUTH 89°47'15" EAST AND ALONG THE NORTHERLY LINE OF INDIAN HEIGHTS 3RD ADDITION, A DISTANCE OF 1922.48 FEET; THENCE SOUTH 0°31'30" EAST AND ALONG THE EASTERLY LINE OF INDIAN HEIGHTS 3RD AND 2ND ADDITIONS, A DISTANCE OF 710.43 FEET; THENCE SOUTH 89°43'30" EAST, A DISTANCE OF 287.15 FEET; THENCE SOUTH 02°5'30" EAST AND ALONG THE EAST LINE OF THE NORTHWEST QUARTER OF SAID SECTION 32, A DISTANCE OF 120.00 FEET; THENCE SOUTH 0°25'30" EAST, A DISTANCE OF 140.0 FEET; THENCE NORTH 89°50'30" EAST AND ALONG THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION 32, A DISTANCE OF 1171.25 FEET; THENCE NORTH 38°39'15" WEST AND ALONG THE APPROXIMATE CENTERLINE OF SPRING CREEK, A DISTANCE OF 490.17 FEET TO THE POINT OF CURVATURE; THENCE NORTHWESTERLY AND ALONG A 238.73 FEET RADIUS CURVE TO THE RIGHT (THE INITIAL TANGENT OF WHICH COINCIDES WITH THE LAST DESCRIBED COURSE), A DISTANCE OF 150.74 FEET TO THE POINT OF TANGENCY; THENCE NORTH 2°28'38" WEST, TANGENT, AND ALONG SAID CENTERLINE, A DISTANCE OF 371.88 FEET TO THE POINT OF CURVATURE; THENCE NORTHWESTERLY AND ALONG A 395.14 FOOT RADIUS CURVE TO THE LEFT (THE INITIAL TANGENT OF WHICH COINCIDES WITH THE LAST DESCRIBED COURSE), A DISTANCE OF 420.44 FEET TO THE POINT OF TANGENCY; THENCE NORTH 63°26'31" WEST, TANGENT, AND ALONG SAID CENTERLINE, A DISTANCE OF 1575.52 FEET TO THE POINT OF CURVATURE; THENCE NORTHWESTERLY AND ALONG A 409.25 FOOT RADIUS CURVE TO THE RIGHT (THE INITIAL TANGENT OF WHICH COINCIDES WITH THE LAST DESCRIBED COURSE), A DISTANCE OF 663.22 FEET; THENCE SOUTH 51°02'23" WEST, A DISTANCE OF 370.10 FEET; THENCE WEST, AND PARALLEL TO THE NORTH SECTION LINE OF SAID SECTION 32, A DISTANCE OF 1036.09 FEET TO THE PLACE OF BEGINNING, ALONG WITH A PERMANENT EASEMENT FROM THE NORTH TO THE ABOVE DESCRIBED TRACT FOR THE PURPOSE OF INGRESS AND EGRESS TO THE NORTHWEST QUARTER OF SECTION 32, TOWNSHIP 10 NORTH, RANGE 21 WEST OF THE 6TH P.M., IN DAWSON COUNTY, NEBRASKA, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS; REFERRING TO THE NORTHWEST CORNER OF SECTION 32, TOWNSHIP 10 NORTH, RANGE 21 WEST OF THE 6TH P.M., IN DAWSON COUNTY, NEBRASKA; THENCE EAST (AN ASSUMED BEARING), AND ALONG THE NORTH LINE OF THE NORTHWEST QUARTER OF SAID SECTION 32, A DISTANCE OF 1194.08 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING EAST, AND ALONG SAID NORTH LINE, A DISTANCE OF 48.70 FEET; THENCE SOUTH 36°24'22" EAST, A DISTANCE OF 190.77 FEET; THENCE SOUTH 51°02'23" WEST, A DISTANCE OF 40.04 FEET; THENCE NORTH 36°24'22" WEST, A DISTANCE OF 222.05 FEET TO THE PLACE OF BEGINNING. 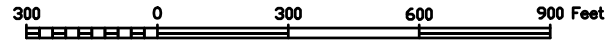

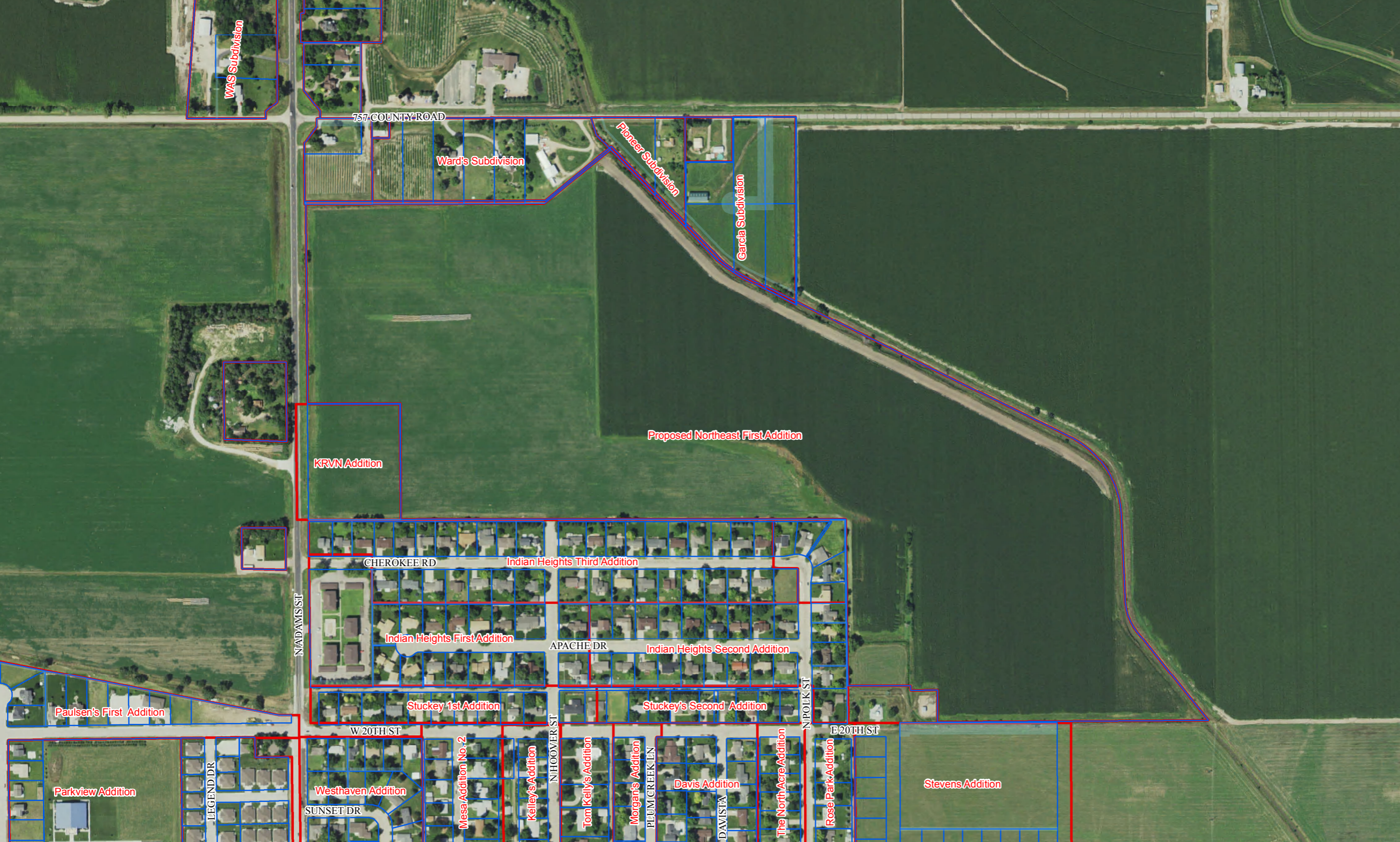
