A regular meeting of the Railroad Transportation Safety District was held on Wednesday, September 11, 2019, at 5:00 p.m., in the Lexington City Council Chambers, at 406 E. 7th Street, Lexington, Nebraska. Notice of the meeting was given in advance by publication in the Lexington Clipper Herald; a copy of the Proof of Publication is on file in the office of the County Clerk. Availability of the agenda was communicated in the publish notice and in the notice to member of the RTSD Board of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Chairman Salem opened the public hearing at 5:02 p.m., for the purpose of hearing support, opposition, criticism, or suggestions relating to the proposed FY 2020 RTSD budget. Requested tax amount is \$173,332.00. Chairman Salem closed the public hearing at 5:06 p.m. Motion was made by Fagot and seconded by Hagan to approve the proposed FY 2020 budget and approve as an audit waiver. Motion was made by Stewart and seconded by Hagan to increase the base of restricted funds by an additional one-percent (1%). Aye: Hagan, Fagot, Roberts, Stewart, Salem. Nay: None. Absent: Rickertsen. Motion carried.

Motion was made by Roberts and seconded by Hagan to approve Resolution #2019-02; approve FY 2020 budget. Aye: Fagot, Roberts, Hagan, Stewart, Salem. Nay: None. Absent: Rickertsen. Motion carried.
